BY HIS EXCELLENCE THE HONOURABLE ERNEST GEORGE JANSEN, DOCTOR OF LAWS, GOVERNOR-GENERAL OF THE UNION OF SOUTH AFRICA.

## PROHIBITION OF THE PRINTING, PUBLICATION OR DISSEMINATION OF "THE GUARDIAN".

Whereas—

(a) the requirements of section seventeen of the Suppression of Communism Act, 1950 (Act No. 44 of 1950), have been complied with in relation to the publication called "The Guardian"; and

Whereas I am satisfied—

(b) (i) that the said publication was published and disseminated by or under the direction or guidance of an organization which has been declared an unlawful organization by section two of the aforesaid Act (namely, the Communist Party of South Africa) immediately prior to the date upon which it became an unlawful organization; and  
(ii) that the said publication did serve *inter alia* as a means for expressing views propagated by the said organization immediately prior to the date upon which it became an unlawful organization;

Now, therefore, under and by virtue of the powers vested in me by section six of the Suppression of Communism Act, 1950 (Act No. 44 of 1950), as amended, I do hereby prohibit the printing, publication or dissemination of the said publication in the Union of South Africa and the Territory of South West Africa.

(b) (i) dat genoemde publikasie deur of onder voor-skrif of leiding van 'n organisasie wat kragtens artikel *twee* van voornoemde Wet tot 'n onwettige organisasie verklaar is (naamlik die Kommunistiese Party van Suid-Afrika), uitgegee of versprei is onmiddellik voor die datum waarop dit 'n onwettige organisasie geword het, en  
(ii) dat genoemde publikasie onder andere gedien het as 'n middel om die sienswysses uit te druk wat deur genoemde organisasie gepropageer is onmiddellik voordat dit 'n onwettige organisasie geword het;

So is dit dat ek, kragtens die bevoegdheid my verleen by artikel *ses* van die Wet op die Onderdrukking van Kommunisme, 1950 (Wet No. 44 van 1950), soos gewysig, hierby die druk, uitgée of verspreiding van genoemde publikasie in die Unie van Suid-Afrika en die Gebied Suidwes-Afrika verbied.
