MAKSIMUM GELDE VIR TOEGANG TOT BIOSKOPE EN ROLPRENTTEATERS.

Ek, Frederick Viljoen Ashpole, Pryskontroleur, handelende krägtens regulasie 3 van Oorlogsmaatreël No. 49 van 1946, bepaal hierby vir die hele Unie, uitgesonderd die mandaatgebied Suidwes-Afrika en die hawe en nedersetting Walvisbaai, as volg:—

1. Die maksimum netto gelde vir toegang tot bioskope en rolprentteaters wat rolprente vertoon, is die gelde wat gewoonlik deur sodanige bioskope en rolprentteaters op 1 Julie 1952 gevra is, plus—

- (a) een pennie by die toegangsgelde van 1s. netto;
- (b) twee pennies by die toegangsgelde van meer as 1s. netto tot en met 2s. 11d. netto; en
- (c) drie pennies by die toegangsgelde van 3s. netto en hoér.

2. Vir die toepassing van hierdie kennisgewing beteken „netto toegangsgelde“ die bruto gelde vir toegang min die vermaaklikheidsbelasting wat krägtens die betrokke ordonnansies van die onderskeie provinsies van die Unie gehef word, en die bykomende 1d. vermeld in Goewermentskennisgewing No. 1817 van 11 September 1942, wat sedertdien verval het.

3. Ingevolge artikel agt van die Wysigingswet op Doeane, 1952 (No. 52 van 1952), is die persentasieverhogings wat in kolom 3 aangegee word teenoor die netto gelde vir toegang tot teaters en ander plekke waar rolprentfilms vertoon word, die persentasies van die onderskeie toegangsgelde wat nie ingerekken word by die berekening van vermaaklikheidsbelasting wat krägtens die betrokke ordonnansies van die onderskeie provinsies van die Unie gehef word nie, nl.—

PRICE CONTROL.

MAXIMUM PRICES OF ADMISSION TO BIOSCOPES AND CINEMA THEATRES.

In terms of regulation 3 of War Measure No. 49 of 1946, I, Frederick Viljoen Ashpole, Price Controller, do hereby throughout the Union, excluding the Mandated Territory of South West Africa and the port and settlement of Walvis Bay:—

1. Fix the maximum net prices of admission to bioscope and cinema theatres exhibiting cinematograph films at the prices ordinarily charged by such bioscope and cinema theatres on the 1st July, 1952, plus—

- (a) one penny to the admission prices of 1s. net;
- (b) twopence to the admission prices over 1s. net up to and including 2s. 11d. net; and
- (c) threepence to the admission prices of 3s. net and over.

2. Direct that for the purpose of this notice “net prices” means the gross prices of admission less any entertainment tax imposed under the relative ordinances of the several provinces of the Union and the additional 1d. referred to in Government Notice No. 1817 of 11th September, 1942, which has since lapsed.

3. In terms of section eight of the Customs Amendment Act, 1952 (No. 52 of 1952), prescribe that the percentage increases shown in column 3 opposite the net admission prices to theatres or other places where cinematograph films are exhibited, shall be the percentages of the respective admission prices not to be taken into account for the purpose of calculating any entertainment tax imposed under the relative ordinances of the several provinces of the Union, viz.—

MAKSIMUM PRYSE VAN MELK.

Ek, Frederick Viljoen Ashpole, Pryskontroleur, handelende kragtens regulasie 3 van Oorlogsmaatreël No. 49 van 1946, bepaal hierby as volg:

1. (1) Die maksimum prys waarteen vars melk 'n distribueerde in die munisipale gebied Bloemfontein deur 'n produseerde verkoop mag word of deur 'n distribueerde van 'n produseerde gekoop mag word, is *two shillings and sixpence* per gallong.

provided that if any fractional variation should occur in applying the foregoing percentages, the amount shown in column 2 opposite the relative percentage shall be deemed to be the correct amount.

4. Withdraw Government Notice No. 1591 of 11th July, 1952 (Maximum Prices of Admission to Bioscopes and Cinema Theatres).

PRICE CONTROL.

MAXIMUM PRICES OF MILK.

In terms of regulation 3 of War Measure No. 49 of 1946, I, Frederick Viljoen Ashpole, Price Controller, do hereby:

1. (1) Fix the maximum price at which fresh milk may be sold to a distributor within the Municipal Area of Bloemfontein by a producer or may be purchased by such a distributor from a producer at *two shillings and sixpence* per gallon.

(2) Die maksimum prys waarteen vars melk aan 'n distribueerde in die munisipale gebied Kimberley deur 'n produseerde verkoop mag word of deur 'n distribueerde van 'n produseerde gekoop mag word, is *twee sjielings en vyf pennies* per gelling.

(3) Die maksimum prys waarteen vars melk in Durban of Pietermaritzburg deur 'n produseerde aan 'n distribueerde verkoop mag word of deur 'n distribueerde van 'n produseerde gekoop mag word, is *twee sjielings en sewe pennies* per gelling.

(4) Die maksimum prys waarteen vars melk aan 'n distribueerde in die gebied Port Elizabeth deur 'n produseerde verkoop mag word of deur 'n distribueerde van 'n produseerde gekoop mag word, is *twee sjielings en ses pennies* per gelling.

(5) Die maksimum prys waarteen vars melk aan 'n distribueerde in Pretoria of aan die Witwatersrand deur 'n produseerde verkoop mag word of deur 'n distribueerde van 'n produseerde gekoop mag word, is *twee sjielings en sewe en 'n halfpennie* per gelling.

(6) Die maksimum prys waarteen vars melk aan 'n distribueerde in die Oranje-Vrystaatse goudveld deur 'n produseerde verkoop mag word of deur 'n distribueerde van 'n produseerde gekoop mag word, is *twee sjielings en ses pennies* per gelling.

2. Die maksimum pryse in paragraaf 1 hiervan vasgestel, sluit in vervoerkoste na die perseel van die distribueerde of na sy naasté stasie.

3. Die pryse vermeld in die Bylae hiervan is die maksimum pryse waarteen vars melk, binne die gebied wat in genoemde Bylae aangegee word, uitgesonderd in die geval van 'n verkoop waarop paragrawe 1 en 2 hiervan van toepassing is; deur enigeen aan iemand anders verkoop mag word.

4. Vir doeleindes van hierdie kennisgewing sluit vars melk gepasteuriseerde melk in.

5. Vir die toepassing van hierdie kennisgewing beteken—

„gebied Port Elizabeth”, die munisipale gebiede Port Elizabeth, Walmer, Uitenhage en Despatch, en die gebiede onder die jurisdiksie van die plaaslike besture te Amsterdamhoek, Bethelsdorp, Mount Pleasant, Perseverance, Redhouse, Schoenmakerskop en Zwartkops; „Pretoria”, ook die dorpe Menlo Park, Waterkloof en Waverley;

„Witwatersrand”, die regsgebiede van die plaaslike besture van Alberton, Alexandra-dorp, Benoni, Boksburg, Brakpan, Edenvale, Germiston, Johannesburg, Kemptonpark, Krugersdorp, Nigel, Randfontein, Roodepoort-Maraisburg, Springs, Vanderbijlpark en Vereeniging;

„Oranje-Vrystaatse Goudveld”, die gebied van die noordwestelike baken van die plaas Roodebloem No. 255 (Distrik Odendaalsrus) in 'n algemene oostelike en suidoostelike rigting om die volgende plase in te sluit: Roodebloem No. 255, Johannesrust No. 385, Aandenk No. 227, R. stoord No. 33, Vriendskap No. 234, Restant van Roodepoort No. 235, Philadelphia No. 273, My Betty No. 351, Dolly No. 404, Ophir No. 405, Erfdeel No. 198, Eva No. 127, Thelma No. 104, Onderverdeling 3 van Eva No. 127, De Hoop No. 276, Wonderkop No. 15, Vooruitgang

(2) Fix the maximum price at which fresh milk may be sold to a distributor within the Municipal Area of Kimberley by a producer or may be purchased by such a distributor from a producer at *two shillings and five pence* per gallon.

(3) Fix the maximum price at which fresh milk may be sold to a distributor at Durban or Pietermaritzburg by a producer or may be purchased by such a distributor from a producer at *two shillings and seven pence* per gallon.

(4) Fix the maximum price at which fresh milk may be sold to a distributor in the Port Elizabeth Area by a producer or may be purchased by such a distributor from a producer at *two shillings and six pence* per gallon.

(5) Fix the maximum price at which fresh milk may be sold to a distributor in Pretoria or on the Witwatersrand by a producer or may be purchased by such a distributor from a producer at *two shillings and seven and one-half pence* per gallon.

(6) Fix the maximum price at which fresh milk may be sold to a distributor within the Orange Free State Goldfields by a producer or may be purchased by such a distributor from a producer at *two shillings and six pence* per gallon.

2. Direct that the maximum prices fixed in paragraph 1 hereof include the cost of transportation to the premises of the distributor or to his nearest station.

3. Fix the prices specified in the Schedule hereto as the maximum prices at which, within the areas specified in the said Schedule, fresh milk may, except in the case of a sale to which paragraph 1 hereof applies, be sold by any person to any other person.

4. Direct that for the purpose of this notice fresh milk includes pasteurised milk.

5. Direct that for the purposes of this notice—

“Cape Peninsula” means the area consisting of the entire Cape Peninsula, bounded on the north by a line extending from Blaauwberg Strand along the road to Potsdam Outspan, at the junction of the Cape Town, Malmesbury and Tyger Valley Roads; thence along the latter road to its intersection with the Bellville-Durbanville Main Road on the farm Elsjes Kraal; thence along the Old Oak Road to its intersection with the Cape Town-Paarl Main Road on the farm Lot H Stikland; thence along the latter road to its intersection with the Cape Divisional Council Division Boundary; thence in a general southerly direction along the last-mentioned boundary to False Bay;

“Port Elizabeth Area” means the municipal areas of Port Elizabeth, Walmer, Uitenhage and Despatch and the areas under the jurisdiction of the local authorities at Amsterdamhoek, Bethelsdorp, Mount Pleasant, Perseverance, Redhouse, Schoenmakerskop and Zwartkops;

“Pretoria” includes the townships of Menlo Park, Waterkloof and Waverley;

“Witwatersrand” means the areas under the jurisdiction of the local authorities at Alberton, Alexandra Township, Benoni, Boksburg, Brakpan, Edenvale, Germiston, Johannesburg, Kempton Park, Krugersdorp, Nigel, Randfontein, Roodepoort, Maraisburg, Springs, Vanderbijlpark and Vereeniging;

“Orange Free State Goldfields” means the area from the north-western beacon of the farm Roodebloem No. 255 (Odendaalsrus District) in a general easterly and south-easterly direction to include the following farms: Roodebloem No. 255, Johannesrust No. 385, Aandenk No. 227, Rustoord No. 33, Vriendskap No. 234, Restant van Roodepoort No. 235, Philadelphia No. 273, My Betty No. 351, Dolly No. 404, Ophir No. 405, Erfdeel No. 198, Eva No. 127, Thelma No. 104, Subdivision 3 of Eva No. 127, De Hoop No.

BEEF PRICES PAYABLE TO PRODUCERS IN CONTROLLED AREAS.

It is hereby notified that the Livestock and Meat Industries Control Board, constituted in terms of section 3 of the Livestock and Meat Control Scheme, published by Proclamation No. 265 of 1945, as amended, has, under the powers vested in it by section 14 of the said scheme, decided that it will, during the period stated in the Schedule hereto in the controlled areas specified in the Schedule buy cattle carcasses from producers of slaughter animals, in the case of—

- (a) any sound carcase, at a price calculated in accordance with a rate specified in the said Schedule;
- (b) any detained carcase, at a price calculated at a rate of ten per cent. less than the rate specified in the said Schedule;

in respect of that controlled area for a carcase of the class or grade specified in that Schedule; provided that if the rates applicable during the week in which the animals received at an abattoir in that controlled area, in accordance with the provisions of a permit issued by the Board, are higher than the rates applicable during the week in which the animals are slaughtered, the prices payable for the carcase shall be calculated at the rates applicable during the week in which the animals are so received.

For the purpose of the aforesaid decision—

“controlled area” means any area specified in Schedule I to Government Notice No. 2097 of 1950, which shall, in terms of a decision of the Board, be an area to which the provisions of this notice shall apply;

RECORD TO BE KEPT BY WHOLESALE BUTCHERS IN CONTROLLED AREAS.

In terms of section *twenty-nine* of the Marketing Act, 1937 (Act No. 26 of 1937), as amended, I, STEPHANUS PETRUS LE ROUX, Minister of Agriculture, hereby make known that the Livestock and Meat Industries Control Board, referred to in section 3 of the Livestock and Meat Control Scheme, published by Proclamation No. 265 of 1945, as amended, has, under the powers vested in it by section 22 of the said Scheme, with my approval, prescribed the record referred to in the Schedule hereto as a record which shall be kept by wholesale butchers in controlled areas and retained by them for the period stated in the said Schedule.

And I hereby further make known that this Notice shall come into operation on 1st September, 1952, from which date Parts A and C of the Schedule to Government Notice No. 2106 of 1950 are repealed.

SCHEDULE.

1. For the purposes of this Schedule any expression to which a meaning has been assigned in the Livestock and Meat Control Scheme, published by Proclamation No. 265 of 1945, as amended, shall have the meaning so thereto assigned. Further unless inconsistent with the context—

“controlled area” shall mean any area specified in Schedule I to Government Notice No. 2097 of 1950; “month” shall mean the period reckoned from the first Monday in any calendar month to the last day of that calendar month if such last day is a Saturday or, if such last day is not a Saturday, to the first Saturday in the next calendar month; “over-issue” or “under-issue” shall mean any quantity of meat issued in excess of or less than the quantity of meat of any particular class to which the purchaser is entitled according to the percentage issue applicable (because of the fact that the total weights of portions issued do not always coincide with the exact weight which has to be issued); “percentage issue” shall mean that percentage of the quota of any purchaser which has been announced by the Board's Local Representative as being available for distribution on any day or during any week; “porkers” shall include sucking pigs as defined in Government Notice No. 2096 of 1950; “purchaser” shall mean a person who is in possession of a quota permit; “quota” shall mean the quantity, in pounds, of meat of a particular class specified in a quota permit; “quota permit” shall mean a written authority issued by the Board authorizing a person to purchase or acquire meat from the wholesale butcher therein specified; “sausagers” shall include larders and roughs as defined in Government Notice No. 2096 of 1950.

2. Every person dealing in the course of trade with meat in a controlled area who sells meat to persons dealing in the course of trade with meat shall—

- (a) keep a record in the form prescribed in the Annexure hereto of the meat supplied by him to every purchaser during any month;
- (b) retain such record for a period of three years reckoned from the last day of the month in respect of which that record had to be kept.

3. Parts A and C of the Schedule to Government Notice No. 2106 of 1950 are hereby repealed.
