PRICE CONTROL.

MAXIMUM PRICES OF BATTERIES (LEAD ACID TYPE) MANUFACTURED IN THE UNION.

In terms of regulation 3 of War Measure No. 49 of 1946, I, Frederick Viljoen Ashpole, Price Controller, hereby amend Government Notice No. 611 of 28th March, 1952 [Maximum Prices of Batteries (Lead Acid Type) Manufactured in the Union] by the substitution of the following paragraph for paragraph 7 thereof:—

“7. Direct that for the purposes of this notice “new battery” means a battery of the lead acid type manufactured in the Union, and “used battery” means a battery of the lead acid type manufactured in the Union or imported.”

PRICE CONTROL.

MAXIMUM PRICES OF BAGS (NEW AND USED), HESSIAN AND WOOLPACKS (NEW AND USED).

In terms of regulation 3 of War Measure No. 49 of 1946, I, Frederick Viljoen Ashpole, Price Controller, hereby:—

1. Amend Government Notice No. 641 of 28th March, 1952 [Maximum Prices of Bags (New and Used), Hessian and Woolpacks (New and Used)], by the substitution of the items in the Schedule hereto for the corresponding items in the Second Schedule thereto.

2. Withdraw Government Notice No. 1407 of 20th June, 1952 [Maximum Prices of Bags (New and Used), Hessian and Woolpacks (New and Used)].
