PRICE CONTROL.

MAXIMUM CHARGES FOR RETREADING OF TYRES AND MAXIMUM PRICES OF TYRE CASINGS (USED).

In terms of regulation 3 of War Measure No. 49 of 1946, I, Harry de Lacy Burnham, Deputy Price Controller, acting under and by virtue of the powers assigned to me by the Price Controller in terms of regulation 1 of the said War Measure, do hereby amend Government Notice No. 2698 of 21st November, 1952 [Maximum Charges for Retreading of Tyres and Maximum Prices of Tyre Casings (Used)], by the substitution of the words "motor vehicle tyres" for the words "motor vehicles" in the definition of "dealer" in paragraph 10 of the English version thereof.
