Ek, Frederick Viljoen Ashpole, Pryskontroleur, handelende kragtens regulasie 3 van Oorlogsmaatreël No. 49 van 1946:—

(1) Wysig Goewermentskennisgewing No. 632 van 28 Maart 1952 hierby deur paragrawe 1 en 2 daarvan te vervang deur die volgende paragrawe 1 en 2:—

1. Die maksimum prys waarteen, binne die gebied wat deur die volgende plekke, die plekke self ingesluit, begrens word, naamlik Bank, Magaliesburg, Brits, Pienaarsrivier, Eerste Fabriek, Welgedacht, Largo, Houtpoort en Wolwehoek, 'n nuwe gegalvaniseerde gegolfde sinkplaat, dikte No. 24, van enige lengte bo 5 voet tot en met 12 voet, vervaardig binne die Unie—

(a) deur 'n oorspronklike koper van 'n herverkoper verkoop mag word, is soos volg:—

(i) As dit 'n plaat van agt drieduimsgolwings is, teen $17\frac{1}{16}$ d. per lengtevoet;

(ii) as dit 'n plaat van tien drieduimsgolwings is, teen $20\frac{1}{16}$ d. per lengtevoet;

(b) deur enige persoon aan enige ander persoon verkoop mag word behalwe in die geval van 'n verkoop deur 'n oorspronklike koper aan 'n herverkoper, is as volg:—

(i) As dit 'n plaat van agt drieduimsgolwings is, teen $18\frac{3}{16}$ d. per lengtevoet;

(ii) as dit 'n plaat van tien drieduimsgolwings is, teen $21\frac{13}{16}$ d. per lengtevoet.

PRICE CONTROL.

MAXIMUM PRICES OF GALVANISED CORRUGATED SHEETS.

In terms of regulation 3 of War Measure No. 49 of 1946, I, Frederick Viljoen Ashpole, Price Controller, do hereby:—

(1) Amend Government Notice No. 632 of 28th March, 1952, by the substitution of the following paragraphs 1 and 2 for paragraphs 1 and 2 thereof:—

1. Fix the maximum price, at which within the area bounded by the following points, which are themselves included, namely Bank, Magaliesburg, Brits, Pienaars River, Eerste Fabriek, Welgedacht, Largo, Houtpoort and Wolwehoek, a new galvanised corrugated sheet gauge 24, of any length exceeding 5 feet up to and including 12 feet, manufactured in the Union—

(a) may be sold by an original purchaser to a reseller as follows:—

(i) If the sheet is of eight three-inch corrugations, at $17\frac{1}{16}$ d. per linear foot;

(ii) if the sheet is of ten three-inch corrugations, $20\frac{1}{16}$ d. per linear foot;

(b) may, except in the case of a sale by an original purchaser to a seller, be sold by any person to any other person as follows:—

(i) If the sheet is of eight three-inch corrugations, at $18\frac{3}{16}$ d. per linear foot;

(ii) If the sheet is of ten three-inch corrugations at $21\frac{13}{16}$ d. per linear foot.

2. Fix the maximum price at which, at any place in the Union outside the area mentioned in paragraph 1 hereof, a new galvanised corrugated sheet gauge 24, of any length exceeding 5 feet up to and including 12 feet, manufactured in the Union—

(a) may be sold by an original purchaser to a reseller as follows:—

(i) If the sheet is of eight three-inch corrugations, at $17\frac{1}{16}$ d. per linear foot;

(ii) if the sheet is of ten three-inch corrugations, at $20\frac{8}{16}$ d. per linear foot;

(b) deur enige persoon aan enige ander persoon verkoop mag word, behalwe in die geval van 'n verkoop deur 'n oorspronklike koper aan 'n herverkoper, is as volg:—

- (i) As dit 'n plaat van agt drieduimsgolwings is, teen $18\frac{1}{16}$ d. per lengtevoet;
- (ii) as dit 'n plaat van tien drieduimsgolwings is, teen $21\frac{1}{16}$ d. per lengtevoet;

met dien verstande dat bogenoemde pryse verhoog mag word met die werklike koste aangegaan in verband met die vervoer van die leveringsbron na die perseel van die verkoper, asook met *two-sestiendes van 'n penny* per lengtevoet vir agt drieduimsgolwings en *drie-sestiendes van 'n penny* vir tien drieduimsgolwings per lengtevoet vir elke vyf-en-twintig myl of gedeelte daarvan ten opsigte van padvervoer na die verkoper se perseel van die stasie of syl af waarheen die plate gestuur word, waar die perseel nie minder as vyf myl van die stasie of syl geleë is nie.

(2) Herroep Goewermentskennisgewing No. 38 van 2 Januarie 1953 betreffende maksimum pryse van gegalvaniseerde gegolfde sinkplate.

PRODUSENTEPRYSE VAN VLEIS EN NEWEPRODUKTE IN BEHEERDE GEBIEDE.—WYSIGING.

Kragtens artikel *nege-en-twintig* van die Bemarkingswet, 1937 (Wet No. 26 van 1937) soos gewysig, maak ek, STEPHANUS PETRUS LE ROUX, Minister van Landbou, hierby bekend dat die Raad van Beheer oor die Vee- en Vleisnywerhede, vermeld in artikel 3 van die Vee- en Vleisreëlingskema, gepubliseer by Proklamasie No. 265 van 1945, soos gewysig, kragtens die bevoegdheid hom verleen by artikel 14 van genoemde Skema met my goedkeuring die Bylae van Goewermentskennisgewing No. 2100 van 1950, soos gewysig, gewysig het op die wyse in die Bylae hiervan uiteengesit.

Voorts maak ek hierby bekend dat hierdie kennisgewing op 25 Januarie 1953 van krag word.

- (ii) if the sheet is of ten three-inch corrugations at $21\frac{1}{16}$ d. per linear foot;

provided that to the following there may be added the actual cost of transportation incurred from the source of supply to the premises of the seller, and also *two-sixtenths of a penny* per linear foot for eight three-inch corrugations and *three-sixtenths of a penny* per linear foot ten three-inch corrugations per twenty-five miles or portion thereof in respect of road transportation to the sellers' premises from the station or siding to which the sheets are consigned, where such premises are not less than five miles from such station or siding.

(2) Withdraw Government Notice No. 38 of 2nd January, 1953, relating to the maximum prices of galvanised corrugated sheets.

PRODUCERS' PRICES FOR MEAT AND BY-PRODUCTS IN CONTROLLED AREAS.—AMENDMENT.

In terms of section *twenty-nine* of the Marketing Act, 1937 (Act No. 26 of 1937) as amended, I, STEPHANUS PETRUS LE ROUX, Minister of Agriculture, hereby make known that the Livestock and Meat Industries Control Board, referred to in section 3 of the Livestock and Meat Control Scheme, published by Proclamation No. 265 of 1945, as amended, has, under the powers vested in it by section 14 of the said Scheme, with my approval amended the Schedule to Government Notice No. 2100 of 1950, as amended, in the manner set out in the Schedule hereto.

And I hereby further make known that this notice shall come into operation on the 25th January, 1953.
