PROCLAMATION.

BY HIS EXCELLENCY THE HONOURABLE ERNEST GEORGE JANSEN, DOCTOR OF LAWS, GOVERNOR-GENERAL OF THE UNION OF SOUTH AFRICA.

PROROGATION OF PARLIAMENT.

WHEREAS by section *twenty* of the South Africa Act, 1909, it is provided that the Governor-General may from time to time, by Proclamation or otherwise, prorogue the Parliament of the Union of South Africa;

AND WHEREAS it is expedient that Parliament shall be prorogued;

NOW, THEREFORE, under and by virtue of the power and authority in me vested, I do by this my Proclamation prorogue the said Parliament of the Union until Friday, the Nineteenth day of June, 1953.
