**MAXIMUM PRICES OF GROCERIES.—BREAKFAST OATS AND OATMEAL.**

In terms of regulation 3 of War Measure No. 49 of 1946,  
I, Frederick Viljoen Ashpole, Price Controller, do  
hereby—

- (1) further amend Government Notice No. 43 of 2nd January, 1953 (Maximum Prices of Groceries), by the substitution of Items Nos. 1—Breakfast Oats and 6—Oatmeal of the Schedules hereto for the corresponding items of the Second, Third and Fourth Schedules thereto.
  - (2) withdraw Government Notice No. 545 of 13th March, 1953 relating to Maximum Prices of Groceries—Breakfast Oats.

## Note.

- (1) The effect of this notice is to make provision for the maximum prices of "Quaker" oats in a new type of container, namely 2-lb. canister.

- (2) The maximum prices as fixed in the withdrawn notice for other brands and packagings remain unchanged.

- (3) The maximum prices of breakfast oats and oatmeal in packings other than those specified in this notice are determinable in accordance with item (4) of the Fifth Schedule to Government Notice No. 43 of 2nd January, 1953.

## CONTROL OF EXPORTS (AMENDMENT).

I, ERIC HENDRIK LOUW, Minister of Economic Affairs, acting under and by virtue of the powers vested in me by War Measure No. 146 of 1942, as amended, read with War Measure No. 75 of 1945, do hereby amend the Schedules to Government Notice No. 2910 of 19th December, 1952, under the respective headings as follows:—

## SCHEDULE A.

## CONTROLLER OF IRON AND STEEL.

By deleting sub-item (ii) of item (2) and substituting the following:—

(ii) Bicycles, tricycles and commercial tricycles, perambulators and baby push carts, motor cycles and aircraft and spares and components therefor."

By the insertion of the word "accounting" after the word "dictaphones" in sub-item (x) of item (2).

By adding the following new sub-item (xv) to item (2):—

"(xv) Gas cylinders of under 25 gallons capacity when used for exporting gas in whatever form."

## CONTROLLER OF MOTOR VEHICLES.

By the insertion of the words "mobile cranes" after the word "bulldozers" in item (2).

## CONTROLLER OF SOAP AND OILS.

By the deletion of items (2) and (8) the existing items (3) to (7) to become items (2) to (6) and the figures (4) and (5) in the note to become figures (3) and (4).

## SCHEDULE B.

## NON-FERROUS MATERIALS.

(a) By the deletion of the word "and" between the words "vanadium" and "zirconium" in item (1) and the addition at the end thereof of the following words:—
