PRICES OF EGGS.—AMENDMENT.

In terms of sub-section (1) of section *twenty-nine* of the Marketing Act, 1937 (Act No. 26 of 1937), as amended, I, STEPHANUS PETRUS LE ROUX, Minister of Agriculture, hereby make known that the Egg Control Board referred to in section 3 of the Egg Control Scheme published by Proclamation No. 8 of 1953, has in terms of section 19 of that Scheme and with my approval, amended the prohibitions made known by Government Notice No. 1299 of 1953, as amended, in the manner indicated in the Schedule hereto.

And I do hereby further make known that the said amendments shall come into operation on the 3rd day of July, 1953.

Government Notice No. 1398 of 26th June, 1953, is hereby repealed.
