Ondergenoemde verbetering word aangebring aan die Bylae van Goewermentskennisgewing No. 1300 van 1953:—

(a) Die bestaande Engelse teks van subparagraaf (ii) van paragraaf (a) van subklousule (1) van klousule 4 word geskrap en vervang deur die volgende subparagraaf:—

„(ii) *Class B*, of carcasses of very good conformation, finish and quality and uniformly covered with a firm creamy white fat, derived from steers and non-pregnant heifers having less than eight permanent incisors;”

(b) In die Afrikaanse teks van subklousule (10) van klousule 7 word die volgende woorde na die woord „appèl,” waar dit vir die tweede keer voorkom:—
„slaag, maar word verbeur indien dit”.

CORRECTION TO GOVERNMENT NOTICE
No. 1300 OF 1953.

The undermentioned corrections are made to the Schedule to Government Notice No. 1300 of 1953:—

(a) The existing English text of sub-paragraph (ii) of paragraph (a) of sub-clause (1) of clause 4 is deleted and the following sub-paragraph substituted therefor:—

“(ii) *Class B*, of carcasses of very good conformation, finish and quality and uniformly covered with a firm creamy white fat, derived from steers and non-pregnant heifers having less than eight permanent incisors;”

(b) In the Afrikaans text of sub-clause (10) of clause 7 the following words are inserted after the word “appèl,” where it occurs for the second time:—
“slaag, maar word verbeur indien dit”.
