### MAKSIMUM PRYSE VAN LUSERN EN LUSERN-MEEL.

Ek, Frederick Viljoen Ashpole, Pryskontroleur, handelende kragtens regulasie 3 van Oorlogsmaatreël No. 49 van 1946—

(1) wysig Goewermentskennisgewing No. 2702 van 21 November 1952 (Maksimum Prys van Lusern en Lusernmeel) hierby verder deur die volgende paragraaf 5 in die plek te stel van paragraaf 5 daarvan:—

5. Wanneer lusern vir herverkoop aangekoop is, en herverkoop word, mag die werklike spoorvrag van die produsent se stasie, tot hoogstens 2s. 3½d. per 100 pond, by die toepaslike maksimum prys hierbo vermeld, gevoeg word, of waar lusern by die perseel van die produsent gekoop word vir herverkoop en anders as per spoor vervoer word, kan die spoorvrag (van hoogstens 2s. 3½d. per 100 lb.) wat betaal sou gewees het indien die lusern per spoor aan die koper versend was, by die toepaslike maksimum prys soos hierbo aangegee, gevoeg word, en waar die lusern aan 'n verbruiker verkoop word, mag die prys verder deur 'n bedrag bereken teen 'n koers van een pennie per 100 lb. per myl ten opsigte van die vervoer van die perseel van die herverkoper na dié van die koper, verhoog word;

### MARKING OF PRICES ON GOODS.—AMENDMENT.

In terms of regulation 9 of War Measure No. 49 of 1946, I, Frederick Viljoen Ashpole, Price Controller, hereby amend Government Notice No. 1840 of 21st August, 1953 (Marking of Prices on Goods) by the insertion of the words "eggs and" after the words "applies to" in subparagraph (5) of paragraph 1 thereof.

NOTE.—The purpose of this notice is to make the provisions of the notice relating to marking of prices on goods applicable to eggs although the maximum prices thereof are no longer determinable under War Measure No. 49 of 1946.

### MAXIMUM PRICES OF LUCERNE AND LUCERNE MEAL.

In terms of regulation 3 of War Measure No. 49 of 1946, I, Frederick Viljoen Ashpole, Price Controller, do hereby—

(1) further amend Government Notice No. 2702 of 21st November, 1952 (Maximum Prices of Lucerne and Lucerne Meal) by the substitution of the following paragraph 5 for paragraph 5 thereof:—

5. Direct that when lucerne is purchased for resale and is resold, the actual railage from the producer's station, not exceeding 2s. 3½d. per 100 lb. may be added to the appropriate maximum price as specified above or where lucerne is purchased at the producer's premises for resale and is transported otherwise than by rail the railage (not exceeding 2s. 3½d. per 100 lb.) that would have been incurred had the lucerne been railed to the ultimate purchaser may be added to the appropriate maximum price specified above and that where lucerne is sold to a consumer, such price may be further increased by an amount calculated at the rate of one penny per 100 lb. per mile in respect of cartage from the premises of the reseller to those of the purchaser;

- (2) herroep hierby Goewermentskennisgewing No. 708 van 2 April 1953 (Maksimum Pryse van Lusern en Lusernmeel).

**PRYSBEHEER.**

**MAKSIMUM PRYSE VAN ONDERDELE (RESERWEDELE) OF TOEBEHORE VIR MOTORVOERTUIE EN BINNEBRANDMOTORE.**

Ek, Frederick Viljoen Ashpole, Pryskontroleur, handende kragtens regulasies 3 en 9 van Oorlogsmaatregel No. 49 van 1946, bepaal hierby vir die hele Unie met uitsondering van die gebied Suidwes-Afrika en die hawe en nedersetting Walvisbaai, as volg:—

1. Die maksimum prys waarteen enige onderdele (reserwedele) of toebehoure vir motorvoertuie en binnebrandmotore, uitgesonderd batterye van die lood-suurtipe en vonkproppe, deur enige aan iemand anders verkoop mag word, is die volgende:—

- (a) Indien van 'n monteur of 'n regstreekse voertuigkonsessiehouer verkry die kosprys van sodanige onderdeel (reserwedele) of toebehoure plus 80 persent daarvan;
- (b) indien van 'n vervaardiger daarvan in die Unie, of deur regstreekse invoer, verkry, die kosprys van sodanige onderdeel (reserwedele) of toebehoure plus 113 persent daarvan.

2. 'n Handelaar wat 'n onderdeel (reserwedele) of toebehoure aan 'n ander handelaar verkoop, moet, benewens die besonderhede wat ingevolge die bepalings van Goewermentskennisgewing No. 566 van 28 Maart 1952 (Uitreiking van Fakte), op 'n faktuur aangegee moet word, daarop die maksimum kleinhandelprys daarvan, bereken ooreenkomsdig paragraaf 1 (a) en (b) van hierdie kennisgewing, endosseer.

3. Vir die toepassing van hierdie kennisgewing beteken—

- „monteur“ 'n konsessiehouer wat gewoonlik motorvoertuie of binnebrandmotore in die Unie monteer;
- „regstreekse voertuigkonsessiehouer“ 'n konsessiehouer wat motorvoertuie of binnebrandmotore, of klaar gemonteerd of geheel en al in stukke invoer;
- „motorvoertuig“ beteken enige meganies aangedrewe vervoermiddel met wiele vir die sleep of vervoer van persoon en/of goedere, en sluit in sleepwaens, motorbote, trekkers en vliegtuie, maar nie trems of trolliebusse (spoorlose trems) nie;
- „binnebrandmotor“ beteken enige diesel-, petrol- of paraffien-aangedrewe binnebrandmotor.

4. Vir die toepassing van paragraaf 1 (b) van hierdie kennisgewing beteken „kosprys“ kosprys vir die fabrikant of invoerder, na gelang van die geval, bereken ooreenkomsdig die bepalings van Goewermentskennisgewing No. 562 van 28 Maart 1952 (Berekening van Kospryse).

- (2) withdraw Government Notice No. 708 of 2nd April 1953 (Maximum Prices of Lucerne and Lucern Meal).

**PRICE CONTROL.**

**MAXIMUM PRICES OF REPLACEMENT PART (SPARES) OR ACCESSORIES FOR MOTOR VEHICLES AND INTERNAL COMBUSTION ENGINES.**

In terms of regulations 3 and 9 of War Measure No. 49 of 1946, I, Frederick Viljoen Ashpole, Price Controller do hereby, throughout the Union, excluding the territory of South West Africa and the Port and settlement of Walvis Bay—

1. Fix the maximum price at which any replacement part (spare) or accessory for motor vehicles and internal combustion engines, except lead acid type batteries and sparkplugs, may be sold by any person to any other person as follows:—

- (a) If acquired from an assembler or direct franchise holder—at the cost of such replacement part (spare) or accessory plus, 80 per cent thereof;
- (b) if acquired from the manufacturer thereof in the Union or imported direct—at the cost of such replacement part (spare) or accessory plus 113 per cent thereof.

2. Direct that any dealer in any sale to any other dealer of any of the replacement parts (spares) or accessories specified in paragraph 1 hereof shall, in addition to the particulars required to be given on an invoice issuable by him in terms of Government Notice No. 566 of the 28th March, 1952 (Issue of Invoices), endorse thereon the maximum retail selling price thereof determined in accordance with paragraph 1 (a) and (b) hereof.

3. Direct that for the purposes of this notice—  
“assembler” means a franchise holder who normally assembles motor vehicles and internal combustion engines in the Union;

“direct franchise holder” means a franchise holder who imports motor vehicles or internal combustion engines either assembled or completely knocked down;

“motor vehicle” means any mechanically propelled wheeled conveyance designed for the haulage or transportation of persons and/or goods, and includes trailers, caravans, motor boats, tractors and aircraft, but excludes tram cars and trolley busses (trackless trams);

“internal combustion engine” means any diesel, petrol or paraffin operated engine.

4. Direct that for the purposes of paragraph 1 (b) of this notice “cost” means cost to the manufacturer or importer as the case may be, determined in accordance with the provisions of Government Notice No. 562 of 28th March, 1952 (Determination of Costs).

5. Goewermentskennisgewing No. 608 van 28 Maart 1952 [Maksimum Pryse van Onderdele (Reservewedele) of Toebehore vir Motorvoertuie] word hierby ingetrek.
