### MAXIMUM PRICES OF ARMS AND AMMUNITION (AMENDMENT).

In terms of regulation 3 of War Measure No. 49 of 1946, I, Frederick Viljoen Ashpole, Price Controller, hereby amend Government Notice No. 615, dated 28th March, 1952 (Maximum Prices of Arms and Ammunition):—

1. By the substitution of the figures 51s. 3d. for the figures 47s. 6d. in paragraph 1 (a) thereof.
2. By the substitution of the figures 32s. and 6s. 6d. for the figures 30s. and 6s. respectively in paragraph 1 (b) thereof.

THE SLAUGHTERING OF SLAUGHTER ANIMALS AND THE ACQUISITION, SALE AND INTRODUCTION OF MEAT IN OUTSIDE AREAS.—AMENDMENT.

Under the powers vested in me by section *twenty-nine* of the Marketing Act, 1937 (Act No. 26 of 1937), as amended, I, STEPHANUS PETRUS LE ROUX, Minister of Agriculture, do hereby amend the prohibitions and exemptions imposed in Schedule I to Government Notice No. 2647 of 1951, as amended, in the manner set out in the Schedule hereto.

And I hereby further make known that this notice shall come into operation on the date of publication thereof.
