PROCLAMATION.

BY HIS EXCELLENCE THE HONOURABLE ERNEST GEORGE JANSEN, DOCTOR OF LAWS, GOVERNOR-GENERAL OF THE UNION OF SOUTH AFRICA.

No. 214, 1953.]

PROROGATION AND SUMMONING OF PARLIAMENT.

WHEREAS by section *twenty* of the South Africa Act, 1909, it is provided that the Governor-General may appoint such times for holding the sessions of Parliament as he thinks fit, and may also from time to time, by Proclamation or otherwise, prorogue Parliament;

AND WHEREAS it is expedient that Parliament shall be prorogued and summoned to meet again;

Now, THEREFORE, under and by virtue of the power and authority vested in me, I do by this my Proclamation—

- (i) prorogue Parliament until Friday, the Twenty-ninth day of January, 1954; and
- (ii) summon Parliament to meet on that day and hereby declare that the Second Session of the Eleventh Parliament of the Union of South Africa will be held at Cape Town on Friday, the Twenty-ninth day of January, 1954, for the despatch of business.

PROROGASIE EN BYEENROEPING VAN DIE PARLEMENT.

- (i) die Parlement tot Vrydag die Nege-en-twintigste dag van Januarie 1954 prorogeer; en
- (ii) die Parlement oproep om op daardie datum byeen te kom, en hierby verklaar dat die Tweede Sessie van die Elfde Parlement van die Unie van Suid-Afrika op Vrydag die Nege-en-twintigste dag van Januarie 1954 te Kaapstad gehou sal word vir die afhandeling van sake.
