### ELECTION OF A SENATOR.

WHEREAS by Proclamation No. 13 of the 14th January, 1955, a vacancy in the representation in the Senate of the province of the Transvaal was declared and the 28th January, 1955, was fixed as the date not later than which the Returning Officer should receive nomination of candidates for election to fill the said vacancy;

AND WHEREAS on the said 28th January, 1955,

- (1) JOHANNES DE KLERK, 850 Government Avenue, Pretoria, Farmer and Business Man,
- (2) FRANCOIS PAULUS THERON, No. 2 Elandsport, Palmford, Farmer,

were duly nominated as candidates;

NOW, THEREFORE, under and by virtue of the provisions of paragraph *forty-four* of the regulations governing the election of Senators, made under sections *twenty-five* and *one hundred and thirty-four* of the South Africa Act, 1909, published under Government Notice No. 2011 of the 8th November, 1920, as amended, I do hereby proclaim that Friday, the 18th day of February, 1955, at 8 o'clock p.m. shall be the date and hour not later than which all marked ballot papers shall be received by the Returning Officer.
