BE IT ENACTED by the Queen's Most Excellent Majesty, the Senate and the House of Assembly of the Union of South Africa, as follows:—

1. The Exchequer Account of the Union is hereby charged with the sum of twelve thousand two hundred and twenty-eight pounds and three pence, to meet certain expenditure over and above the amounts appropriated for the service of the Union for the year which ended on the thirty-first day of March, 1954. Such expenditure is set forth in the Schedule to this Act and is more particularly specified on pages 13 and 15 of the Report (which has been submitted to Parliament) of the Controller and Auditor-General on the accounts for the said year and in the First Report of the Select Committee on Public Accounts, 1955.

2. This Act shall be known as the Unauthorized Expenditure (1953-'54) Act, 1955.

To apply a sum not exceeding eighty-three million pounds on account of the service of the Union for the year ending the thirty-first day of March, 1956.

BE IT ENACTED by the Queen's Most Excellent Majesty, the Senate and the House of Assembly of the Union of South Africa, as follows:—

1. On and after the first day of April, 1955, there may be issued out of the Exchequer Account such sums of money not exceeding in the aggregate the sum of sixty-three million pounds for revenue services, two million pounds for Bantu Education and eighteen million pounds for loan services as may from time to time be required for the service of the Union for the year ending on the thirty-first day of March, 1956, until such time as provision is made therefor by Parliament in an Appropriation Act.

2. All sums issued under the provisions of this Act shall be deemed to be advances on account of grants to be made by Parliament in an Appropriation Act for the year ending the thirty-first day of March, 1956, and upon the commencement of such Appropriation Act, this Act shall cease to have effect and issues already made hereunder shall be deemed to be issues under that Appropriation Act, and shall be accounted for in accordance with the provisions thereof:

Provided that no services upon which expenditure has not been duly authorized under an Appropriation Act during the year ending the thirty-first day of March, 1955, or for which there is no statutory authority, shall be deemed to be authorized under section one of this Act.

To apply a further sum not exceeding thirteen million and sixty-three thousand three hundred and thirty-seven pounds towards the service of the Union for the year ending on the thirty-first day of March, 1955.

(Assented to 15th March, 1955.)*

BE IT ENACTED by the Queen's Most Excellent Majesty, the Senate and the House of Assembly of the Union of South Africa, as follows:—

Exchequer Account charged with sums not exceeding £5,048,080 on revenue account.

1. The Exchequer Account is hereby charged with such sums of money as may be required for the service of the Union (and chargeable to revenue account) during the year ending on the thirty-first day of March, 1955, not exceeding in the whole the sum of five million and forty-eight thousand and eighty pounds, in addition to the sums with which that Account has been charged by the Appropriation Act, 1954 (Act No. 57 of 1954).

Exchequer Account charged with sums not exceeding £8,015,257 on loan account.

2. The Exchequer Account is further charged with such sums of money as may be required for the service of the Union (and chargeable to loan account) during the year ending on the thirty-first day of March, 1955, not exceeding in the whole the sum of eight million and fifteen thousand two hundred and fifty-seven pounds, in addition to the sums with which that Account has been charged by the Appropriation Act, 1954 (Act No. 57 of 1954).

How money to be applied.

3. The money appropriated by this Act shall be applied to the services detailed in the Schedule hereto, and more particularly specified in the Estimates of Additional Expenditure [U.G. 2—1955] as approved by Parliament, and to no other purpose.

Minister may approve variation.

4. With the approval of the Minister of Finance, a saving on any sub-head of a vote may be made available to meet excess expenditure on any other sub-head, or expenditure on a new sub-head of the same vote: Provided that no excess shall be incurred on the sums appearing in column 2 of the Schedule hereto, nor shall savings thereon be available for any purpose other than that for which the money is hereby granted as indicated in the said Schedule.

ACT

To amend the Exchequer and Audit Act, 1911, to provide for the establishment of a Bantu Education Account for the financing of Bantu Education.

(English text signed by the Governor-General.)
(Assented to 16th March, 1955.)

BE IT ENACTED by the Queen's Most Excellent Majesty, the Senate and the House of Assembly of the Union of South Africa, as follows:—

Insertion of
section 22*bis*
in Act 21 of
1911.

1. The following section is hereby inserted after section *twenty-two* of the Exchequer and Audit Act, 1911:

"Bantu Education Account. 22*bis*. (1) There shall be credited to an account called 'The Bantu Education Account'—

- (a) an amount of six million five hundred thousand pounds in respect of every financial year, which amount shall be transferred from the Revenue Account in such instalments and at such times as the Treasury may determine;
- (b) four-fifths of the amount of the general tax collected under the provisions of the Natives Taxation and Development Act, 1925 (Act No. 41 of 1925);
- (c) such moneys as Parliament may make available, in the form of recoverable advances, to meet any deficiency in the aforesaid Bantu Education Account;
- (d) any receipts arising from the maintenance, management and control of Government Bantu schools, other than receipts arising from the sale of land or buildings;
- (e) any moneys which may accrue to the said Bantu Education Account from any other source whatsoever.

(2) The moneys so credited shall be kept in the Exchequer Account and shall, subject to the provisions of the Bantu Education Act, 1953 (Act No. 47 of 1953), and in accordance with estimates approved by Parliament, be utilized for Bantu Education."

1. Die volgende artikel word hiermee na artikel *twee-entwintig* in die „Financiewet, 1911”, ingevoeg:

„Bantoe-onderwysrekening.

22bis. (1) Er wordt in een rekening bekend als „De Bantoe-onderwijsrekening” gestort—

- (a) een bedrag van zes miljoen vijfhonderd duizend pond ten opzichte van elk financieel jaar, welk bedrag in de paalementen en op de tijden door de Thesaurie bepaald uit de Inkomsterekening overgedragen wordt;
- (b) vier-vijfden van het bedrag van de algemene belasting ingevolge de bepalingen van de Naturelle Belasting en Ontwikkeling Wet, 1925 (Wet No. 41 van 1925), geïnd;
- (c) de gelden die het Parlement bij wijze van verhaalbare voorschotten beschikbaar mocht stellen ten einde enig tekort in voormelde Bantoe-onderwijsrekening aan te zuiveren;
- (d) enige ontvangsten ontstaande uit het onderhoud, bestuur en beheer van Staatsbantoescholen, uitgezonderd ontvangsten ontstaande uit de verkoop van grond of gebouwen;
- (e) enige gelden die uit enige andere bron hoege-naamd aan bedoelde Bantoe-onderwijsrekening toevallen.

(2) De aldus gestorte gelden blijven in de Schatkistrekening en worden, behoudens de bepalingen van de „Wet op Bantoe-onderwys, 1953” (Wet No. 47 van 1953), en overeenkomstig een begroting door het Parlement goedgekeurd, voor Bantoe-onderwijs aangewend.”
