MAXIMUM PRICES OF GROCERIES.

In terms of regulation 3 of War Measure No. 49 of 1946, I, Harry de Lacy Burnham, Price Controller, hereby amend Government Notice No. 636 of 25th March, 1955 (Maximum Prices of Groceries) by the deletion of the words "or 2" where they appear in paragraph 2 thereof.

DRIED FRUIT SCHEME.

REGISTRATION OF CERTAIN PERSONS DEALING IN THE COURSE OF TRADE WITH DRIED FRUIT.

His Excellency the Governor-General has, under the powers vested in him by section forty-three of the Marketing Act, 1937 (Act No. 26 of 1937), as amended, made the following regulations prescribing the requirements with which certain persons dealing in the course of trade with dried fruit should comply so as to be registered in terms of section 19 of the Dried Fruit Scheme published by Proclamation No. 332 of 1949, as amended. Government Notice No. 8 of 1940, as amended by Government Notice No. 682 of 1941 is hereby repealed.

No person dealing in the course of trade with dried fruit shall be registered by the Dried Fruit Board (hereinafter called the Board), established under section two of Proclamation No. 332 of 1949, as amended, for the purposes of section 19 of the Dried Fruit Scheme, to receive dried fruit from producers, to process, grade and to pack dried fruit unless he complies with the following requirements:—

1. (a) He must have at his disposal premises approved by the Board and suitable for receiving, processing, grading and packing dried fruit.

DROËVRUGTESKEMA.

REGISTRASIE VAN SEKERE PERSONE WAT MET DROËVRUGTE AS 'N BESIGHEID HANDEL.

Sy Eksellensie die Goewerneur-generaal het, kragtens die bevoegdheid aan hom verleen by artikel drie-en-veertig van die Bemarkingswet, 1937 (Wet No. 26 van 1937), soos gewysig, die volgende regulasies gemaak waarby die vereistes voorgeskryf word waaraan sekere persone wat met droëvrugte as 'n besigheid handel, moet voldoen om ingevolge artikel 19 van die Droëvrugteskema, gepubliseer by Proklamasie No. 332 van 1949, soos gewysig, geregistreer te word. Goewermentskennisgewing No. 8 van 1940, soos gewysig by Goewermentskennisgewing No. 682 van 1941, word hierby herroep.

Niemand wat met droëvrugte as 'n besigheid handel, word deur die Droëvrugteraad (hierna die Raad genoem), ingestel kragtens artikel twee van Proklamasie No. 332 van 1949, soos gewysig, vir die toepassing van artikel 19 van die Droëvrugteskema geregistreer om droëvrugte te ontvang van produsente, dit te verwerk, te gradeer en te verpak nie, tensy hy aan die volgende vereistes voldoen:—

1. (a) Hy moet beskik oor persele wat deur die Raad goedgekeur is en wat geskik is vir die ontvangs, verwerking, gradering en verpakking van droëvrugte.

(b) Stores and packing sheds on such premises shall be so constructed as to minimise harbourage for insects. The floors shall be of concrete or other material which can be rapidly and easily cleaned, scrubbed and washed.

(c) Such stores and packing sheds shall be properly lighted and ventilated.

(d) The walls of such packing sheds shall be at least ten feet high.

(e) Adequate provision should be made for toilet and change rooms for employees.

(f) Adequate facilities should be provided for the easy removal of dust, trash, screenings and fruit debris at any time during processing or packing operations.

2. For the purposes of these regulations any expression used herein has the same meaning as has been assigned to it in the Marketing Act, 1937 (Act No. 26 of 1937), as amended, and the Dried Fruit Scheme (Proclamation No. 332 of 1949), as amended.

(b) Pakhuise en verpakkingskure op sodanige persele moet so gebou wees dat hulle so min moontlik skuiling vir insekte verskaf. Die vloere moet van beton wees of van 'n materiaal wat vinnig en maklik skoongemaak, geskrop en gewas kan word.

(c) Sodanige pakhuise en verpakkingskure moet behoorlik vèrlig en belug wees.

(d) Die mure van sodanige verpakkingskure moet minstens tien voet hoog wees.

(e) Daar moet voldoende voorsering wees vir was- en kleekamers vir werkemers.

(f) Toereikende fasiliteite moet verskaf word sodat stof, uitskot, sifse en vrugte-afval op enige tyd gedurende verwerking of verpakking maklik weggeruim kan word.

2. Vir die toepassing van hierdie regulasies het elke uitdrukking hierin gebruik dieselfde betekenis as wat daarvan in die Bemarkingswet, 1937 (Wet No. 26 van 1937), soos gewysig, en die Droëvrugteskema (Proklamasie No. 332 van 1949), soos gewysig, geheg is.
