Om ondersoek in te stel na en verslag uit te bring oor—

(1) die doeltreffendheid, al dan nie, van die stelsel van toekenning van dranklisensies deur plaaslike dranklisensieraade soos dit tans kragtens die Drankwet, 1928 (Wet No. 30 van 1928) bestaan en in die besonder of—

(a) die huidige wyse van verteenwoordiging by wyse van benoemings deur plaaslike owerhede en die Regering doeltreffend is;

- (b) the qualifications and disqualifications of members of boards contained in the existing Act are adequate;
 (c) the existing provisions of the Act for the control of the actions of the licensing authority and for subjecting such actions to review and/or appeal are effective and to make recommendations;

in accordance with the findings, for the introduction of some other system of granting licences with a view to replacing or improving the existing system; and

- (2) the desirability or otherwise of prohibiting the tied-house system by legislation.
