APPOINTMENT OF MEMBERS.

It is hereby notified for general information that His  
Excellency the Governor-General has been pleased,  
under and by virtue of the powers vested in him by  
section three of the Group Areas Development Act, 1955  
(Act No. 69 of 1955)—

  - (vi) meneer Gabriel Francois de Vos Hugo, met meneer Johannes Daniel Jacobus Roux as plaasvervangende lid (beide benoem deur die Minister van Binnelandse Sake);
  - (vii) meneer Irving Steyn, met meneer Edward Alfred Bouchier as plaasvervangende lid (beide benoem deur die Minister van Binnelandse Sake); en
- (b) genoemde meneer Willem Hendrik Lategan Heckroodt as Voorsitter van bedoelde Raad aan te wys.

Verder het Sy Eksellensie die Goewerneur-generaal, ingevolge die bevoegdheid hom verleent by sub-artikel (1) van artikel vier van voormalde Wet, goedgekeur—

- (a) dat genoemde meneer Willem Hendrik Lategan Heckroodt vir 'n tydperk van vyf jaar vanaf 1 Februarie 1956 aangestel word; en

- (vi) Gabriel Francois de Vos Hugo, Esq., with Johannes Daniel Jacobus Roux, Esq., as alternate member (both nominated by the Minister of the Interior);
- (vii) Irving Steyn, Esq., with Edward Alfred Bouchier, Esq., as alternate member (both nominated by the Minister of the Interior);

- (b) to designate the abovenamed Willem Hendrik Lategan Heckroodt, Esq., as chairman of the said board.

Further, His Excellency the Governor-General has been pleased, under and by virtue of the powers vested in him by sub-section (1) of section four of the said Act, approve—

- (a) that the said Willem Hendrik Lategan Heckroodt, Esq., be appointed for a period of five years with effect from the 1st February, 1956; and
- (b) that the other persons whose names are indicated above be appointed, in each case, for a period three years with effect from the 1st February, 1956.
