DRIED FRUIT SCHEME.

MAXIMUM PRICES OF DRIED FRUIT.

In terms of section *twenty-nine* of the Marketing Act, 1937 (Act No. 26 of 1937), as amended, I, STEPHANUS PETRUS LE ROUX, Minister of Agriculture, hereby make known that the Dried Fruit Board, referred to in section 2 of the Dried Fruit Scheme, published by Proclamation No. 332 of 1949, as amended, has in terms of section 18 of the said scheme, and with my approval, imposed the prohibition specified in the Annexure hereto in connection with the sale of dried fruit, in substitution of Government Notice No. 611 of 25th March, 1955, as amended.

And I hereby further make known that the said prohibition shall become operative on the date of publication of this notice.

ANNEXURE.

1. Whenever dried fruit of the varieties and grades specified in the First, Second and Third Schedules hereto is sold—

- no registered dried fruit packer shall sell such dried fruit to a wholesaler at a price higher than that specified in Schedule 1 for the variety and grade, as the case may be;
- no wholesaler shall sell such dried fruit to a retailer at a price higher than that specified in Schedule 2 for the variety and grade, as the case may be;
- no person shall, except in the case of a sale to which sub-paragraph (a) or (b) applies, sell such dried fruit to any other person at a price higher than that specified in Schedule 3 for the variety and grade, as the case may be.

2. For the purpose of this notice—

“registered dried fruit packer” means a person registered in terms of section 19 of the Dried Fruit Scheme and also includes persons not so registered;

“grade” (“grades”) means the grade (grades) as determined by Government Notice No. 2450 of 14th December, 1945;

“Class A” and “Class B”, in the Schedules, bear the meaning as defined in sub-paragraph (2) (a) of paragraph 4 of the Schedule to Government Notice No. 2450 of 14th December, 1945.

En voorts maak ek hierby bekend dat genoemde verbodsbepaling op die datum van publikasie van hierdie kennisgewing in werking tree.

1. Wanneer droëvrugte van die soorte en grade genoem in die Eerste, Tweede en Derde Bylaes hiervan, verkoop word—

- mag geen geregistreerde droëvrugteverpakker sodanige droëvrugte teen 'n hoër prys as dié in Bylae 1 vir die betrokke soort en graad bepaal, na gelang van die geval, aan 'n groothandelaar verkoop nie;
- mag geen groothandelaar sodanige droëvrugte, teen 'n hoër prys as dié in Bylae 2 vir die betrokke soort en graad bepaal, na gelang van die geval, aan 'n kleinhandelaar verkoop nie; en
- mag niemand sodanige droëvrugte, uitgesonderd in die geval van 'n verkoping waarop subparagraaf (a) of (b) van toepassing is, teen 'n hoër prys as dié in Bylae 3 vir die betrokke soort en graad bepaal, na gelang van die geval, aan iemand anders verkoop nie.
