INDUSTRIAL CONCILIATION ACT, 1937.

JEWELLERY AND PRECIOUS METAL INDUSTRY.

I, JOHANNES DE KLERK, Minister of Labour, do hereby—

- (a) in terms of sub-section (1) of section forty-eight of the Industrial Conciliation Act, 1937, declare that all the provisions of the Agreement which appears in the Schedule hereto, and which relates to the Jewellery and Precious Metal Industry, shall be binding from the second Monday after the date of publication of this notice and for the period ending the 31st August, 1956, upon the employers' organisation and trade union which entered into the said Agreement and upon the employers and employees who are members of that organisation or that union;
- (b) in terms of sub-section (2) of section forty-eight of the said Act, declare that the provisions contained in sections 1 and 2 of the said Agreement shall be binding from the second Monday after the date of publication of this notice and for the period ending on the 31st August, 1956, upon the other employers and employees engaged or employed in the said Industry in the Magisterial Districts of Pretoria, Johannesburg, Randfontein, Krugersdorp, Roodepoort, Germiston, Boksburg, Benoni, Brakpan, Springs and Nigel; and
- (c) in terms of sub-section (4) of section forty-eight of the said Act, declare that in the Magisterial Districts of Pretoria, Johannesburg, Randfontein, Krugersdorp, Roodepoort, Germiston, Boksburg, Benoni, Brakpan, Springs and Nigel and from the second Monday after the date of publication of this notice and for the period ending on the 31st August, 1956, the provisions contained in sections 1 and 2 of the said Agreement shall *mutatis mutandis* apply in respect of such persons in the said Industry as are not included in the definition of the expression "employee" contained in section one of the said Act.

- (a) kragtens subartikel (1) van artikel *agt-en-veertig* van die Nywerheid-versoeningswet, 1937, dat al die bepalings van die Ooreenkoms wat in die Bylae verskyn en op die Juwele- en Edelmetaalnywerheid betrekking het, van die tweede Maandag na die datum van publikasie van hierdie kennisgewing af en vir die tydperk wat op 31 Augustus 1956 eindig, bindend is vir die werkgewersorganisasie en die vakvereniging wat genoemde Ooreenkoms aangaan het en vir die werkgewers en werknemers wat lede van daardie organisasie of daardie vereniging is;
- (b) kragtens subartikel (2) van artikel *agt-en-veertig* van genoemde Wet dat die bepalings in klousules 1 en 2 van genoemde Ooreenkoms vervat, van die tweede Maandag na die datum van publikasie van hierdie kennisgewing af en vir die tydperk wat op 31 Augustus 1956 eindig, bindend is vir die ander werkgewers en werknemers betrokke by of in diens in genoemde nywerheid in die magistraatsdistrikte Pretoria, Johannesburg, Randfontein, Krugersdorp, Roodepoort, Germiston, Boksburg, Benoni, Brakpan, Springs en Nigel; en
- (c) kragtens subartikel (4) van artikel *agt-en-veertig* van genoemde Wet dat die bepalings in klousules 1 en 2 van genoemde Ooreenkoms vervat, van die tweede Maandag na die datum van publikasie van hierdie kennisgewing af en vir die tydperk wat op 31 Augustus 1956 eindig, in die magistraatsdistrikte Pretoria, Johannesburg, Randfontein, Krugersdorp, Roodepoort, Germiston, Boksburg, Benoni, Brakpan, Springs en Nigel *mutatis mutandis* van toepassing is ten opsigte van persone in genoemde nywerheid wat nie by die woordomskrywing van die uitdrukking „werknemer”, vervat in artikel *een*, van genoemde Wet, ingesluit is nie.

SCHEDULE.

INDUSTRIAL COUNCIL FOR THE JEWELLERY AND PRECIOUS METAL INDUSTRY.

AGREEMENT

in accordance with the provisions of the Industrial Conciliation Act, 1937, between the

Transvaal Jewellers' Association

(hereinafter referred to as "the employers" or "the employers' Organisation") of the one part, and the

Jewellers' and Goldsmiths' Union

(hereinafter referred to as "the employees" or "the trade union") of the other part,

being parties to the Industrial Council for the Jewellery and Precious Metal Industry,

to amend the Agreement published under Government Notice No. 1669, dated 19th August, 1955 (hereinafter referred to as the Main Agreement), as follows:—

(1) *Section 5, sub-section (3) (Main Agreement).*—After the words "during such rest interval the employer shall provide" add the words "free of charge".

(2) *Section 14. Annual Holiday Leave.*—Add the additional sub-sections:—

9. Every employer shall pay to the Industrial Council an amount equal to 25 per cent of the total gross full weekly wages (including cost of living allowance) payable to all persons in his employ as at the last pay day in each month for the months of January to 30th October of each year. Such amount to be remitted together with Annexure "J" by not later than the tenth of each month.

10. For the purposes of sub-section (9) of this section the Industrial Council shall maintain a trust account, and shall receive into the said trust account all moneys so paid, and shall issue a receipt for every such payment showing the said moneys to have been received into the said trust account, and the name of the employer paying the same.

11. During the week immediately preceding the 30th November the Industrial Council shall pay to the employers entitled thereto respectively the total amount of all moneys received in trust from them as aforesaid, less the amounts payable by them in terms of sub-section (6) of this section, since the preceding annual holiday leave period; provided that the Council may at any earlier time pay to any employer the whole or any part of the moneys received in trust from him as aforesaid since the preceding annual holiday leave period, in circumstances recognised by the Council as sufficient to warrant such earlier payment.

12. The cost of the administering the special account referred to in section (9) of this section shall be borne by the Industrial Council which may, at its discretion, invest any of the funds on hand with an approved bank and/or building society and any interest accruing from such investment shall be retained by the Industrial Council towards the costs of administration of the aforesaid special account.

(3) *Section 19 to be amended to be 19A.*

New Section.

19B. SUBSCRIPTION TO TRADE UNION AND EMPLOYERS' ORGANISATION.

(1) Every employer shall by authority of this Agreement deduct from the weekly wages of each person in his employ affected by this Agreement, the amount of the subscriptions payable by such person to the trade union and shall forward on the prescribed form the amount thus deducted to the Secretary of the Trade Union, P.O. Box 8530, Johannesburg, not later than the tenth day of each month in the form prescribed in Annexure "J".

(2) Every employer shall, in respect of membership of the Employers' Association, remit $\frac{1}{12}$ th of his annual fees to the Secretary of the Council, 503 Empire Building, Kruis Street, Johannesburg, not later than the tenth day of each month in the form prescribed in Annexure "F".

BYLAE.

NYWERHEIDSRAAD VIR DIE JUWELE- EN EDELMETAALNYWERHEID.

OOREENKOMS

ingevolge die bepalings van die Nywerheid-versoeningswet, 1937, gesluit en aangegaan tussen die

Transvaal Jewellers' Association

(hieronder die „werkgewers” of die „werkgewersorganisasie” genoem), aan die een kant, en die

Jewellers' and Goldsmiths' Union

(hieronder die „werkneemers” of die „vakvereniging” genoem), aan die ander kant,

wat die partye is by die Nywerheidsraad vir die Juwele- en Edelmetaalnywerheid,

ten einde die Ooreenkoms gepubliseer by Goewermentskennisgowing No. 1669 van 19 Augustus 1955 (hieronder die Hoofooreenkoms genoem), soos volg te wysig:—

(1) *Artikel 5, subartikel (3) (Hoofooreenkoms).*—Voeg die woord „kosteloos” in na die woorde „tee of koffie”.

(2) *Artikel 14, Jaarlikse vakansieverlof.*—Voeg die volgende addisionele subartikels by:—

9. Elke werkgewer moet aan die Nywerheidsraad 'n bedrag betaal gelyk aan 25 persent van die totale bruto volle weekloon (met inbegrip van lewenskostetoelae) betaalbaar aan alle persone in sy diens op die laaste betaaldag in elke maand vir die maande Januarie tot 30 Oktober iedere jaar. Sodanige bedrag moet saam met Aanhangel J op of voor die tiende van elke maand opgestuur word.

10. Vir die toepassing van subartikel (9) van hierdie artikel moet die Nywerheidsraad 'n trustrekening in stand hou, en moet alle geld aldus betaal, in dié trustrekening stort, en moet 'n kwitantie vir elke sodanige betaling uittrek waarin aangetoon word dat genoemde geld in genoemde trustrekening gestort is, asook die naam van die werkgewer wat sodanige geld inbetaal word.

11. Gedurende die week onmiddellik voor 30 November moet die Nywerheidsraad aan die onderskeie werkgewers wat daarop geregtig is, die totale bedrag aan alle geld wat in trust van hulle, soos vermeld, ontvang is, uitbetaal, min die bedrae betaalbaar deur hulle ingevolge subartikel (6) van hierdie artikel, sedert die vorige jaarlikse vakansieverlof; met dien verstande dat die Raad op enige vroeë tydstip aan 'n werkgewer die hele of enige gedeelte van die geld kan betaal wat, soos vermeld, van hom in trust sedert die vorige jaarlike verlof ontvang is, onder omstandighede wat deur die Raad as genoegsaam beskou word om sodanige vroeë betaling te wettig.

12. Die koste van die administrasie van die spesiale rekening genoem in subartikel (9) van hierdie artikel moet gedra word deur die Nywerheidsraad wat na goeddunke enige van die fondse voorhande, by 'n bank en/of bougenootskap kan bêlê, en enige rente wat uit sodanige belegging gekweek word, moet deur die Nywerheidsraad gehou word ter bestryding van die administrasiekoste van voornoemde spesiale rekening.

(3) *Artikel 19 moet 19A hernommer word.*

Nuwe artikel.

19B. LEDEGELD AAN VAKVERENIGING EN WERKGEWERSORGANISASIE.

(1) Elke werkgewer moet, op magtiging van hierdie Ooreenkoms, van die weekloon van elke persoon in sy diens wat deur hierdie Ooreenkoms geraak word, die bedrag aan ledegeld wat deur sodanige persoon aan die vakvereniging betaalbaar is, afgetrek, en die bedrag aldus afgetrek, op die voorgeskrewe vorm aan die Sekretaris van die Vakvereniging, Posbus 8530, Johannesburg, op of voor die tiende dag van elke maand, in die vorm voorgeskryf in Aanhangel J, stuur.

(2) Elke werkgewer moet, ten opsigte van lidmaatskap van die werkgewersorganisasie, 1/12de van sy jaarlikse gelde aan die Sekretaris van die Raad, Empiregebou 503, Kruisstraat, Johannesburg, op of voor die tiende van elke maand, in die vorm voorgeskryf in Aanhangel F, stuur.

Aanhangel J moet gewysig word deur die bykomende gegevens wat daarby gaan.

Aanhangel F moet gewysig word deur die insluiting van die bykomende bepalings wat daarby gaan.
