PRICES OF EGGS.—AMENDMENT.

In terms of sub-section (1) of section *twenty-nine* of the Marketing Act, 1937 (Act No. 26 of 1937), as amended, I, STEPHANUS PETRUS LE ROUX, Minister of Agriculture, hereby make known that the Egg Control Board, referred to in section 3 of the Egg Control Scheme, published by Proclamation No. 8 of 1953, as amended, has in terms of section 19 of that Scheme and with my approval amended the prohibitions made known by Government Notice No. 1217 of 6th July, 1956, in the manner indicated in the Schedule hereto.

And I do hereby further make known that the said amendments shall come into operation on the 16th day of July, 1956.

MAXIMUM PRICES OF MILK.

In terms of War Measure No. 49 of 1946, I, Harry de Lacy Burnham, Price Controller, hereby—

(1) further amend Government Notice No. 646 of 25th March, 1955 (Maximum Prices of Milk) by—

(a) deleting the words “two shillings and seven and one-halfpence” and substituting the words “two shillings and ninepence” in paragraph 1 (6) thereof;

(b) substituting Parts E—Pietermaritzburg, H—Durban and J—Orange Free State Gold-fields, as specified in the Schedule hereto for the corresponding parts of the Schedule thereto;

(2) amend Government Notice No. 1063 of 15th June, 1956 (Maximum Prices of Milk) by deleting Parts E—Pietermaritzburg and H—Durban in the Schedule thereto.
