In terms of War Measure No. 49 of 1946, I, Harry de Lacy Burnham, Price Controller, hereby, with effect from 27th August, 1956—

- (1) further amend Government Notice No. 646 of 25th March, 1955 (Maximum Prices of Milk), as amended, by substituting the Schedule hereto for the corresponding Part of the Schedule thereto;
- (2) withdraw Government Notice No. 1317 of 24th June, 1955 (Maximum Prices of Milk).
