MAXIMUM PRICES OF CEMENT.

In terms of War Measure No. 49 of 1946, I, Harry de Lacy Burnham, Price Controller, prescribe hereby, as follows:—

1. The maximum price at which, in the undermentioned areas, cement may be sold to a dealer or to a contractor by a dealer who acquired it from the manufacturer thereof, is as follows:—

- (a) Within the Cape Town area, at 5s. per pocket;
- (b) within the municipal area of Mossel Bay, at 6s. 1½d. per pocket;
- (c) within the municipal area of East London, at 5s. 11d. per pocket;
- (d) within the Port Elizabeth area, at 5s. per pocket;
- (e) within the Durban area, at 5s. 11½d. per pocket;
- (f) within the municipal area of Pietermaritzburg, at 6s. 0½d. per pocket;
- (g) within the Pretoria area, at 4s. 9d. per pocket;
- (h) within the Witwatersrand area, at 5s. 1½d. per pocket;
- (i) within the municipal area of Bloemfontein, at 5s. 3½d. per pocket;

2. The maximum prices at which, in the undermentioned areas, cement may be sold by any person (excluding a manufacturer of cement) to any other person in any transaction to which paragraph 1 hereof does not apply, is as follows:—

- (a) Within the Cape Town area, at 5s. 3d. per pocket;
- (b) within the municipal area of Mossel Bay, at 6s. 4½d. per pocket;
- (c) within the municipal area of East London, at 6s. 2d. per pocket;
- (d) within the Port Elizabeth area, at 5s. 3d. per pocket;
- (e) within the Durban area, at 6s. 2½d. per pocket;
- (f) within the municipal area of Pietermaritzburg, at 6s. 3½d. per pocket;
- (g) within the Pretoria area, at 5s. per pocket;
- (h) within the Witwatersrand area, at 5s. 4½d. per pocket;
- (i) within the municipal area of Bloemfontein, at 5s. 6½d. per pocket;

1. Die maksimum prys waarteen sement in ondervermelde gebiede aan 'n handelaar of aan 'n kontrakteur verkoop mag word deur 'n handelaar wat dit van die vervaardiger daarvan verkry het, is die volgende:—

- (a) Binne die gebied Kaapstad, 5s. per sakkie;
- (b) binne die munisipale gebied van Mosselbaai, 6s. 1½d. per sakkie;
- (c) binne die munisipale gebied van Oos-Londen, 5s. 11d. per sakkie;
- (d) binne die gebied Port Elizabeth, 5s. per sakkie;
- (e) binne die gebied Durban, 5s. 11½d. per sakkie;
- (f) binne die munisipale gebied van Pietermaritzburg, 6s. 0½d. per sakkie;
- (g) binne die gebied Pretoria, 4s. 9d. per sakkie;
- (h) binne die gebied Witwatersrand, 5s. 1½d. per sakkie;
- (i) binne die munisipale gebied van Bloemfontein, 5s. 3½d. per sakkie.

2. Die maksimum prys waarteen sement in ondervermelde gebiede deur iemand (uitgesonderd 'n vervaardiger van sement) aan enigiemand anders verkoop mag word in 'n transaksie waarop paragraaf 1 hiervan nie van toepassing is nie, is die volgende:—

- (a) Binne die gebied Kaapstad, 5s. 3d. per sakkie;
- (b) binne die munisipale gebied van Mosselbaai, 6s. 4½d. per sakkie;
- (c) binne die munisipale gebied van Oos-Londen, 6s. 2d. per sakkie;
- (d) binne die gebied Port Elizabeth, 5s. 3d. per sakkie;
- (e) binne die gebied Durban, 6s. 2½d. per sakkie;
- (f) binne die munisipale gebied van Pietermaritzburg, 6s. 3½d. per sakkie;
- (g) binne die gebied Pretoria, 5s. per sakkie;
- (h) binne die gebied Witwatersrand, 5s. 4½d. per sakkie;
- (i) binne die munisipale gebied van Bloemfontein, 5s. 6½d. per sakkie.

3. The maximum price at which cement may be sold at any other place in the Union excluding the Territory of South West Africa and the port and settlement of Walvis Bay—

(a) by dealers ex stock—

- (i) to contractors, is the list price plus 6d. per pocket;
- (ii) to other purchasers, is the list price plus 7½d. per pocket;

(b) by dealers on direct railings ex factory—

- (i) to contractors, in the case of 200 pocket lots or more, is the list price plus 3d. per pocket and in the case of smaller quantities (minimum 24 pockets) is the list price plus 4½d. per pocket;
- (ii) to other purchasers in the case of 200 pocket lots or more, is the list price plus 4½d. per pocket; and, in the case of smaller quantities (minimum 24 pockets), is the list price plus 6d. per pocket.

4. The maximum prices as fixed in paragraphs 1, 2 and 3 hereof may in sales of "Eland" cement at and south of Touws River be increased by 3d. per pocket.

5. The maximum prices chargeable under—

- (a) paragraphs 1 and 2 hereof include delivery within the areas specified therein; and
- (b) paragraph 3 hereof include delivery within the area of the local authority in which the seller's premises are situated.

6. For the purposes of this notice—

"Cape Town area" means the municipal areas of Cape Town, Bellville, Durbanville, Fish Hoek, Goodwood, Milnerton, Parow, Pinelands and Simonstown, the local board area of Constantia, and the townships of Ottery, Wetton and Bergvliet and includes a stretch of a 100 yards on either side of the Durbanville Road between Bellville and Durbanville;

"Port Elizabeth area" means the area bounded by the Indian Ocean from the South bank of the Swartkops River mouth to a point opposite the Humewood golf course club-house and thence along a line drawn to the Southern end of Seventeenth Avenue, Walmer, to Cape Road at the Kragga Kama Road intersection to Cradock Place, to the village of Swartkops and thence to the first-mentioned point;

"Durban area" means the area within a radius of 15 miles from the Durban Central Post Office, including Amanzimtoti, Kloof and Umhlanga Rocks;

"Pretoria area" means the municipal areas of Pretoria and Pretoria North and includes the townships of East Lynne, Menlo Park, Silverton, Waterkloof and Waverley;

"Witwatersrand areas" means the municipal areas of Alberton, Benoni, Boksburg, Brakpan, Germiston, Johannesburg, Kempton Park (including Isando), Krugersdorp, Nigel, Randfontein, Roodepoort-Maraisburg, and Springs, and includes the Native townships of Alexandra, Dube, Jabavu, Mofolo, Meadowlands, Moroka, Noordgesig, Orlando East and Orlando West;

"pocket" means a bag containing 94 lb. nominal weight of cement;

"contractors" means bona fide building contractors or constructional engineers engaged in building construction and includes churches, convents, missionary societies, hospital boards; and

"list price" means the manufacturer's list price as shown in the Schedule hereto plus, at places where no Railway cartage facilities exist, the actual cartage charges not exceeding 2d. per bag.

3. Die maksimum prys waarteen sement op enige ander plek in die Unie, uitgesond van die gebied Suidwes-Afrika en die hawe en nedersetting Walvisbaai, verkoop mag word—

(a) deur handelaars uit voorrade—

- (i) aan kontrakteurs is die lysprys plus 6d. per sakkie;
- (ii) aan ander kopers, is die lysprys plus 7½d. per sakkie;

(b) deur handelaars op regstreekse spoorversending van die fabriek af—

- (i) aan kontrakteurs, in die geval van hoeveelhede van 200 sakkies of meer, is die lysprys plus 3d. per sakkie, en in die geval van kleiner hoeveelhede (minimum 24 sakkies), die lysprys plus 4½d. per sakkie;
- (ii) aan ander kopers in die geval van hoeveelhede van 200 sakkies of meer, is die lysprys plus 4½d. per sakkie en in die geval van kleiner hoeveelhede (minimum 24 sakkies), die lysprys plus 6d. per sakkie.

4. Die maksimum prys soos in paragrawe 1, 2 en 3 hiervan vasgestel is, kan by verkoop van "Eland" sement op en ten suide van Touwsrivier met 3d. per sakkie verhoog word.

5. Die maksimum prys wat gevorder mag word kragtens—

(a) paragrawe 1 en 2 hiervan sluit afluwing binne genoemde gebiede in; en

(b) paragraaf 3 hiervan sluit afluwing binne die gebied van die plaaslike bestuur, waarin die verkoper se persele geleë is in.

"gebied Durban", die gebied binne 'n omtrek van 15 myl van die Durbanse Sentrale Poskantoor af, en sluit Amanzimtoti, Kloof en Umhlanga Rocks in;

"gebied Pretoria", die munisipale gebiede Pretoria en Pretoria-Noord, en sluit die dorpsgebiede East Lynne, Menlo Park, Silverton, Waterkloof en Waverley in;

"gebied Witwatersrand", die munisipale gebiede Alberton, Benoni, Boksburg, Brakpan, Germiston, Johannesburg, Kemptonpark (met inbegrip van Isando), Krugersdorp, Nigel, Randfontein, Roodepoort-Maraisburg en Springs, en sluit die Naturelle dorpsgebiede Alexandra, Dube, Jabavu, Meadowlands, Mofolo, Moroka, Noordgesig, Orlando-Oos en Orlando-Wes in;

"sakkie", 'n sak wat 94 pond nominale gewig sement bevat;

"kontrakteurs", bona fide-boukontrakteurs of konstruksie-ingenieurs, met inbegrip van kerke, kloosters, sendinggenootskappe en hospitaalrade, wat bouwerk verrig; en

"lysprys", die fabrikant se lysprys soos in die Bylae hiervan vervat, plus, op plekke waar daar geen spoorwegafleveringsfasiliteite bestaan nie, die werklike vervoerkoste tot hoogstens 2d. per sak.

7. The maximum prices specified in this notice relate to ordinary Portland cement and not to special types of cement.

NOTE.—This notice represents a Consolidation of the withdrawn notices. The opportunity has, however, been taken to complete the revision of cement prices, in which the third of the withdrawn notices, i.e. No. 1380 of 27th July, 1956, constituted the first major step.

This has involved the setting of new prices at Cape Town, Port Elizabeth and Pretoria. The prices at these centres were not affected by the notice just quoted.
