MEALIE AND KAFFIRCORN CONTROL SCHEME.

PRODUCERS' PRICES OF MEALIES

In terms of sub-section (1) of section twenty-nine of the Marketing Act, 1937 (Act No. 26 of 1937), as amended, I, STEPHANUS PETRUS LE ROUX, Minister of Agriculture, hereby make known that the Mealie Industry Control Board referred to in section 3 of the Mealie and Kaffircorn Control Scheme published by Proclamation No. 64 of 1957, has, in terms of section 27 of that scheme, with my approval and with effect from 1st May, 1957, imposed the prohibitions mentioned—

- (a) in Schedule A hereto in connection with the sale of mealies by producers of mealies in Area A as defined in clause 4 of Schedule B hereto; and
- (b) in Schedule B hereto in connection with the sale of mealies by producers of mealies in Area B as defined in clause 4 of Schedule B hereto;

in substitution for the prohibitions promulgated in Government Notice No. 741 of 27th April, 1956, and these prohibitions shall remain in force until the 30th April, 1958, unless amended at an earlier date.

 - (a) mealies, excluding mealies intended for seed purposes, of any of the classes and grades mentioned in Table A hereunder, at a price other than the price specified in column 1 of that table for mealies of that class and grade if such mealies are delivered in new grainbags or in grade 1 second-hand grainbags as defined in clause 4 of Schedule B hereto;

- (e) sample grade mealies contained in grainbags at a price higher than 28s. 9d. per bag;
- (f) mealies, excluding mealies intended for seed purposes, in loose quantities of less than 200 lb. at a time—
- (i) of any of the classes and grades mentioned in the table above, at a price other than 1½d. per lb.;
 - (ii) which are sample grade mealies, at a price higher than 1½d. per lb.

2. In the calculation of the price payable in accordance with clause 1 any fraction of a penny, if less than a half-penny may be regarded as a half-penny, and if more than a half-penny may be regarded as a penny.

3. The prices for the respective classes and grades of mealies specified in clause 1, shall apply in respect of mealies delivered free on rail producer's nearest railway station or siding, or delivered to the premises of the buyer, at whichever point delivery is effected in terms of the conditions of sale of the mealies.

DEFINITIONS.

4. For the purpose of this Government Notice—

(a) "Area A" shall mean the area comprising the provinces of Transvaal and the Orange Free State and the Magisterial Districts of Mafeking and Vryburg in the province of the Cape of Good Hope;

- (e) monstergraadmielies wat in graansakke bevat is, teen 'n hoër prys as 28s. 9d. per sak verkoop nie;
- (f) mielies, uitgesonderd mielies bestem vir saaddoeleindes, in los hoeveelhede van minder as 200 lb. tegelyk verkoop—
- (i) teen 'n ander prys as 1½d. per lb. waar sodanige mielies van een of ander van die klasse en grade in die tabel hierbo genoem, is nie;
 - (ii) teen 'n hoër prys as 1½d. per lb. waar sodanige mielies monstergraadmielies is nie.

WOORDOMSKRYWING.

4. Vir die doeleindes van hierdie Goewermentskennisgewing—

(a) beteken „gebied A“ die gebied bestaande uit die provinsies Transvaal en Oranje-Vrystaat en die magistraatsdistrikte Mafeking en Vryburg in die provinsie die Kaap die Goeie Hoop;

- (b) "Area B" shall mean the area comprising the provinces of Natal and the Cape of Good Hope, excluding the Magisterial Districts of Mafeking and Vryburg;
- (c) "bag" in relation to mealies shall mean a quantity of mealies of a gross weight of 203 lb. determined on a moisture content not exceeding 12½ per cent by weight; provided that the tare of an empty grain-bag shall be deemed to be 3 lb;
- (d) the classes and grades of mealies referred to in the said prohibitions shall be the classes and grades described in the Schedule to Government Notice No. 752 of 1955, as amended;
- (e) "grade 1 second-hand grainbags" shall mean grain-bags that are sound, clean, unstained and free from holes or patches but darned where necessary; provided that patches not exceeding 4 square inches affixed with a patching compound approved by the Controller of Jute Goods, shall for the purpose of grading, be treated as if they were darns;
- (f) "grade 2 second-hand grainbags" shall mean grain-bags that are sound, clean, unstained and free from holes, but darned and/or patched; the maximum area of any individual patch not exceeding 36 square inches;
- (g) "sell" shall have the meaning assigned thereto in the Marketing Act, 1937 (Act No. 26 of 1937), as amended;
- (h) "weevilly mealies" shall mean mealies infested with live weevils or other live insects injurious to stored grain irrespective of whether such insects are present in the mealies or on the containers of the mealies.

EXPLANATORY NOTE.

The producers' prices in Area A are subject to the special levy of 1s. 3d. per bag promulgated by Government Notice No. 585 of the 26th April, 1957. This levy will be deducted from the producers' price by the Board or its agent at the time of delivery. The producers' net prices in Area A are therefore 1s. 3d. per 200 lb. less than the prices published in Schedule A to this Notice.

The published producers' prices in Area B are the same as the net prices to producers in Area A. In Area B, however, the levy is not included in the prices published in Schedule B to this Notice.

SPECIAL LEVIES ON MEALIES.

In terms of section twenty-nine of the Marketing Act, 1937 (Act No. 26 of 1937), as amended, I, STEPHANUS PETRUS LE ROUX, Minister of Agriculture, hereby make known that the Mealie Industry Control Board, referred to in section 3 of the Mealie and Kaffircorn Control Scheme, published by Proclamation No. 64 of 1957, has, in terms of section 23 of that Scheme, with my approval and with effect from the 1st May, 1957, imposed the special levies mentioned in the Schedule hereto in substitution for the special levies imposed in terms of Government Notice No. 740 of 27th April, 1956.

SCHEDULE.

1. A special levy of 1s. 9d. per 200 lb. is hereby imposed on all mealies intended for use as seed which are sold by or on behalf of producers of mealies in the Union.

- (b) beteken „gebied B” die gebied bestaande uit die provinsies Natal en die Kaap die Goeie Hoop, uitgesonderd die magistraatsdistrikte Mafeking en Vryburg;
- (c) beteken „sak” met betrekking tot mielies, 'n hoeveelheid mielies van 203 lb. bruto gewig, bereken op 'n voggehalte van hoogstens 12½ persent volgens gewig; met dien verstande dat die tarra van 'n leë graansak as 3 lb. gereken word;
- (d) is die klasse en grade mielies wat in genoemde verbodsbeplings gemeld word, die klasse en grade wat in die Bylae van Goewermentskennisgewing No. 752 van 1955, soos gewysig, omskryf word;
- (e) beteken „graad 1 tweedehandse graansakkie”, graansakkie wat sterk, skoon, ongevlek en sonder gate of lappelike is maar gestop waar nodig; met dien verstande dat lappe van hoogstens vier vierkante duim, aangeplak met 'n lapkleefstof wat deur die Kontroleur van Jutegoedere goedgekeur is vir die doel van gradering beskou word as stopsels;
- (f) beteken „graad 2 tweedehandse graansakkie”, graansakkie wat sterk, skoon, ongevlek en sonder gate is, maar gestop en/of gelap; die maksimum grootte van 'n afsonderlike lappelik mag hoogstens 36 vierkante duim wees;
- (g) het die woord „verkoop” die betekenis wat in die Bemarkingswet, 1937 (Wet No. 26 van 1937), soos gewysig, daaraan geheg word;
- (h) beteken „kalanderbesmette mielies”, mielies wat met lewendige kalanders of ander lewendige insekte wat skadelik is vir opgebergde graan besmet is, ongeag of sodanige insekte in die mielies of op die houers van die mielies voorkom.

VERKLARENDE OPMERKING.

Die produsentepryse in gebied A is onderworpe aan die spesiale heffing van 1s. 3d. per sak, afgekondig by Goewermentskennisgewing No. 585 van 26 April 1957. Hierdie heffing sal deur die Raad of sy agent van die produsenteprys afgetrek word wanneer levering plaasvind. Die netto produsentepryse in gebied A is dus 1s. 3d. per 200 lb. minder as die prys wat in Bylae A van hierdie kennisgewing gepubliseer word.

Die gepubliseerde produsentepryse in gebied B is die selfde as die netto prys aan produsente in gebied A. In gebied B is die heffing egter nie ingesluit in die prys wat in Bylae B in hierdie kennisgewing gepubliseer word nie.

3. A special levy of 1s. 9d. per 200 lb. is hereby imposed on all mealies, excluding all grades of yellow mealies and all mealies intended for use as seed, which are sold by or on behalf of producers of mealies in Area B.

4. A special levy of 1s. 3d. per 200 lb. is hereby imposed on all grades of yellow mealies, excluding all mealies intended for use as seed, which are sold by or on behalf of producers of mealies in Area B.

DEFINITIONS.

For the purpose of this Government Notice—

“Area A” shall mean the area comprising the Provinces of Transvaal and the Orange Free State and the Magisterial Districts of Mafeking and Vryburg, in the Province of the Cape of Good Hope;

“Area B” shall mean the area comprising the Provinces of Natal and the Cape of Good Hope, excluding the Magisterial Districts of Mafeking and Vryburg;

the “grades of yellow mealies” shall mean Yellow Flint and Yellow Dent mealies Grades 1 and 2 and Yellow Undergrade mealies Grades 4 and 5 as described in Government Notice No 752 of 1955, as amended;

the word “producer” shall have the meaning assigned thereto in the Mealie and Kaffircorn Control Scheme, published by Proclamation No. 64 of 1957; and

the word “sold” shall have the meaning assigned thereto in the Marketing Act, 1937 (Act No. 26 of 1937), as amended.

EXPLANATORY NOTES.

(a) In Area A the agent of the Board is authorised to deduct the levy of 1s. 3d. per bag from the producer's fixed price (viz. 30s. per bag for the best grades). The producer, therefore, receives a net price of 28s. 9d. per bag while the Board sells that maize at basic prices of 30s. 6d. per bag in respect of white mealies and 30s. per bag in respect of yellow mealies. The difference of 1s. 9d. and 1s. 3d. respectively is retained by the Board.

(b) In Area B the producer's price (for best grades) has been fixed at 28s. 9d. per bag but here too maize should cost the registered trader at least 30s. 6d. per bag for white maize and 30s. per bag for yellow maize as is the case with buyers in Area A. However, he pays the producer only 28s. 9d. per bag and the differences of 1s. 9d. and 1s. 3d. per bag respectively must, therefore, be paid over to the Board by the trader.

His Excellency the Governor-General has, under the powers vested in him by section forty-three of the Marketing Act, 1937 (Act No. 26 of 1937), as amended, and with effect from 1st May, 1957, issued the regulations set out in the Schedule hereto in connection with the times at which and the manner in which any levies imposed on mealies sold by or on behalf of producers of mealies shall be paid, in substitution for the regulations promulgated by Government Notice No. 742 of 27th April, 1956.

SCHEDULE.

1. Any levy imposed by the Mealie Industry Control Board, referred to in section 3 of the Mealie and Kaffircorn Control Scheme, published by Proclamation No. 64

- (a) in the case of mealies sold by or on behalf of a producer of mealies in Area A to the Board or to an agent of the Board, be deducted by the Board or its agent from the price payable to such producer;
- (b) in the case of mealies sold by or on behalf of a producer of mealies in Area B (excluding a producer who is also a merchant), to a person dealing in the course of trade with mealies, be paid by the purchaser of such mealies to the Mealie Industry Control Board, P.O. Box 669, Pretoria, within 10 days after the end of each calendar month during which the mealies were thus sold;
- (c) in all other cases of mealies sold by or on behalf of a producer of mealies (including a producer who is also a merchant) be paid to the Mealie Industry Control Board, P.O. Box 669, Pretoria, by such producer within 10 days after the end of each calendar month during which the mealies were thus sold.

2. Any person who contravenes or fails to comply with any provision of these regulations shall be guilty of an offence and liable on conviction to a fine not exceeding one hundred pounds.

DEFINITIONS.

For the purpose of this Government Notice—

- (a) "Area A" shall mean the area comprising the Provinces of Transvaal and the Orange Free State and the Magisterial Districts of Mafeking and Vryburg, in the Province of the Cape of Good Hope;
- (b) "Area B" shall mean the area comprising the Provinces of Natal and the Cape of Good Hope, excluding the Magisterial Districts of Mafeking and Vryburg;
- (c) the words "producer" and "merchant" shall have the meaning respectively assigned thereto in the said scheme; and
- (d) the word "sold" and the expression "dealing in the course of trade" shall have the meaning respectively assigned thereto in the Marketing Act, 1937 (Act No. 26 of 1937), as amended.

In terms of sub-section (1) of section *twenty-nine* of the Marketing Act, 1937 (Act No. 26 of 1937), as amended, I, STEPHANUS PETRUS LE ROUX, Minister of Agriculture, do hereby make known that the Mealie Industry Control Board, referred to in section 3 of the Mealie and Kaffircorn Control Scheme, published by Proclamation No. 64 of 1957, has in terms of section 27 of that scheme and with my approval, imposed the prohibitions mentioned—

- (a) in Schedule A hereto in connection with the sale of mealies in quantities of not less than one bag at a time to a particular person, by a person dealing in the course of trade with mealies;
- (b) in Schedule B hereto in connection with the sale of mealie products in quantities of not less than one bag at a time to a particular person—
 - (i) by a person who manufactures mealie products or on whose behalf mealie products are manufactured; and
 - (ii) by a person who does not manufacture mealie products or on whose behalf mealie products are not manufactured; and

in substitution for the prohibitions made known in Schedules A, B and C to Government Notice No. 743 of 27th April, 1956, as amended by Government Notices Nos. 833 of 11th May, 1956, 1761 of 21st September, 1956, 238 of 15th February, 1957, and 288 of 22nd February, 1957, with effect from 1st May, 1957, and these prohibitions shall remain in force until the 30th day of April, 1958, unless amended at an earlier date.

- (a) mealies intended for seed purposes, at a price less than 30s. 6d. per bag;
- (b) sample grade mealies, contained in grainbags, at a price higher than 30s. 6d. per bag.

2. The prices specified in clause 1 may be increased—

- (1) by an amount not exceeding 10d. per 200 lb. net weight in respect of mealies sold in quantities of five to nine bags at a time to any one person, and by an amount not exceeding 1s. 5d. per 200 lb. net weight in respect of mealies sold in quantities of one to four bags at a time to any one person;

(2) in respect of transport costs actually incurred by the seller—

(a) where rail facilities are available—

- (i) by an amount equal to the railage charges (including siding charges) laid down by the South African Railways Administration in connection with the transport by rail of such mealies; or
- (ii) by an amount equal to the average railage charges per bag of mealies received during the calendar month preceding that calendar month during which the sale is effected if such mealies are sold for delivery from the business premises of the seller;

(a) transport charges from the place of manufacture to the premises of the buyer or person who receives such mealie product on his behalf when such product is transported otherwise than by Railway Road Motor Service or rail; and

(b) railage to the nearest station of the buyer or person who receives the mealie product on his behalf, when such product is transported by rail, and shall be reduced by an amount equal to the railage thereon to the nearest station of such buyer or person if such railage is not paid by the seller.

3. The prices specified in clause 1 may be increased—

(a) by an amount not exceeding 8d. per 180 lb. net weight when the total quantity of such mealie product sold to any one person at one and the same time is less than 1,800 lb.;

(b) when such mealie product is delivered by rail to the nearest station of the buyer, by an amount equal to that amount by which the actual railage charges per 200 lb. of mealie product, thus incurred exceeds 1s. 3d. per 200 lb.;

(d) when such mealie product is transported by the Railway Road Motor Service, by the tariff laid down by the South African Railways Administration in respect of such transport;

(e) by 2½d. per 180 lb. net weight in respect of every month or part thereof after the end of that month which immediately follows the month during which delivery or despatch of such mealie product was effected and during which the price remains unpaid.

4. Notwithstanding any contrary provision contained in these regulations, any mealie product railed in a quantity of 540 lb. or less at a time to any particular person, may be sold free on rail sender's nearest railway station or siding at the prices applicable to sales of less than 1,800 lb., less an amount of 8d. per 180 lb.

5. In the calculation of the price of a mealie product in terms of the foregoing provisions, an amount of less than a halfpenny—

(a) may be increased to a halfpenny if such mealie product is packed in a container holding 90 lb. or more of that product;

(b) may, where such mealie product is packed in a container holding less than 90 lb., be increased to a halfpenny per 100 lb. of that product.

TRADERS' PRICES OF MEALIE PRODUCTS.

Sales in Bag Lots.

6. No person shall sell any mealie product specified in Tables E, F and G hereunder and not manufactured by himself or by any other person on his behalf, in a quantity mentioned in the said tables, and contained in a jute or hessian, or in a cotton or linen bag, at a price higher than that specified in the said tables in respect of that mealie product; provided that the prices mentioned in the said tables shall be reduced by 8d. per 180 lb. of such mealie product where the total quantity of that mealie product sold to any person at one and the same time is not less than 1,800 lb.

8. In the calculation of any price in accordance with clauses 6 and 7, any fraction of a penny, if less than a halfpenny, may be regarded as a halfpenny, and if more than a halfpenny, may be regarded as a penny.

- (a) ordinary levy: 4s. per animal;
- (b) special stabilisation levy: 3s. 6d. per animal;
i.e. a total of 7s. 6d. per animal.

(2) *Calves*—

- (a) ordinary levy: 6d. per animal;
- (b) special stabilisation levy: 3d. per animal;
i.e. a total of 9d. per animal.

(3) *Sheep, Lambs, Goats and Kids*—

- (a) ordinary levy: 6d. per animal;
- (b) special stabilisation levy: 4d. per animal;
i.e. a total of 10d. per animal.

(4) *Pigs*—

- (a) ordinary levy: 1s. 3d. per animal;
- (b) special stabilisation levy: 2s. 3d. per animal;
i.e. a total of 3s. 6d. per animal.

(5) *Sucking Pigs*—

- (a) ordinary levy: 3d. per animal;
- (b) special stabilisation levy: 3d. per animal;
i.e. a total of 6d. per animal.

NOTES.

1. Payment of the levies is governed by sub-sections (2), (3) and (4) of section 15 of the Scheme which read as follows:—

"(2) Every person who owns or is in charge of any abattoir or slaughter-pole referred to in sub-section (1) other than an abattoir or slaughter-pole controlled by a local authority within a controlled area shall, not later than the fifteenth day of each calendar month—

(a) furnish to the Board an accurate statement in a form prescribed by regulation showing the sex and number of cattle and calves and the number of sheep, goats, pigs and sucking pigs slaughtered at that abattoir or slaughter-pole during the preceding calendar month;

(b) pay to the Board the amount due in respect of levy on cattle, calves, sheep, goats, pigs and sucking pigs referred to in paragraph (a) by virtue of any levies imposed in terms of sub-section (1).

(3) Any person paying any money to the Board in terms of sub-section (2) in respect of an animal of which he was not the owner may recover the amount involved from the person by whom or at whose instance that animal was slaughtered and such last-mentioned person may, if he was not the owner, recover that amount from the owner.

(4) Any person paying any money to the Board in terms of sub-section (2) in respect of an animal of which he was not the owner shall be entitled to receive commission from the Board at a rate to be determined by the Board with the approval of the Minister on the amount so paid."
