In terms of War Measure No. 49 of 1946, I, Johannes Jacobus Kitshoff, Deputy Price Controller, acting by virtue of the powers assigned to me by the Price Controller in terms of Regulation 1 of the said War Measure, do hereby amend the Second and Third Schedules to Government Notice No. 715 of 20 April, 1956 (Maximum Prices of Groceries) under the heading—

SECOND SCHEDULE.

MAXIMUM WHOLESALE PRICES.

Item No. 1: Condensed Milk.
