REGULASIES KAGTENS DIE WET OP DESIMALE MUNT, 1959.

Sy Eksellensie die Goewerneur-generaal het, kragtens die bevoegdheid hom verleen by paragraaf (b) van sub-artikel (1) van artikel *agt* van die Wet op Desimale Munt, 1959 (Wet No. 61 van 1959), die volgende regulasies uitgevaardig:—

HOOFTUK II.

REGISTRASIE VAN £.S.D.-KASREGISTERMASJIENE, OPTEL(REKEN)-MASJIENE EN BOEKHOU-MASJIENE.

1. In hierdie regulasies, tensy uit die samehang anders blyk, beteken—

- (i) „£.s.d.”, met betrekking tot 'n masjien, dat so 'n masjien bedoel is of gebruik word vir die aantekening of berekening van bedrae uitgedruk in die munte waarvoor voorsiening gemaak word in die Bylae by die Muntwet, 1922 (Wet No. 31 van 1922);
- (ii) „mechaniese omskakeling”, die fisiese omskakeling van 'n masjien wat bedoel is of gebruik word vir die aantekening van bedrae wat in £.s.d. uitgedruk word na die munstelsel waarvoor voorsiening gemaak word in die Wet op Desimale Munt, 1959;
- (iii) „persoon” en „eienaar”, wanneer met betrekking tot masjiene gebesig, ook die Staat;
- (iv) „Raad”, die Desimalisasieraad ingestel ingevolge artikel *drie* van die Wet op Desimale Munt, 1959;
- (v) „vervangingskompensasie”, kompensasie wat betaal mag word met betrekking tot verliese gely deur eienaars van £.s.d.-masjiene as gevolg van die invoering van die munstelsel waarvoor die Wet op Desimale Munt, 1959, voorsiening maak;
- (vi) „Unie”, dat dit insluit die gebied Suidwes-Afrika, met inbegrip van daardie deel van bedoelde gebied bekend as die Oostelike Caprivi Zipfel waarna in artikel *drie* van die Wysigingswet op Aangeleenthede van Suidwes-Afrika, 1951 (Wet No. 55 van 1951), verwys word, en daardie deel van bedoelde gebied wat as die „Rehoboth Gebiet” bekend staan en in die Eerste Bylae by Proklamasie No. 28 van 1923 van die Administrateur van daardie gebied omskryf word.

REGULATIONS IN TERMS OF THE DECIMAL COINAGE ACT, 1959.

His Excellency the Governor-General, under the powers conferred upon him by paragraph (b) of sub-section (1) of section *eight* of the Decimal Coinage Act, 1959 (Act No. 61 of 1959), has made the following regulations:—

CHAPTER II.

REGISTRATION OF £.S.D. CASH REGISTER MACHINES, ADDING (CALCULATING) MACHINES AND ACCOUNTING MACHINES.

1. In these regulations, unless the context otherwise indicates—

- (i) “Board” means the Decimalization Board established in terms of section *three* of the Decimal Coinage Act, 1959;
- (ii) “£.s.d.” in relation to a machine means that such a machine is intended or used for the recording or calculation of amounts expressed in the coinage provided for in the Schedule to the Coinage Act, 1922 (Act No. 31 of 1922);
- (iii) “mechanical conversion” means the physical conversion of a machine intended or used for the recording of amounts expressed in £.s.d. to the coinage system provided for in the Decimal Coinage Act, 1959;
- (iv) “person” and “owner” when used in relation to machines include the State;
- (v) “replacement compensation” means compensation which may be paid in respect of losses incurred by owners of £.s.d. machines in consequence of the introduction of the coinage system provided for in the Decimal Coinage Act, 1959;
- (vi) “Union” includes the territory of South West Africa, including that portion of the said territory known as the Eastern Caprivi Zipfel and referred to in section *three* of the South West Africa Affairs Amendment Act, 1951 (Act No. 55 of 1951), and that portion of the said territory known as the “Rehoboth Gebiet” and defined in the First Schedule to Proclamation No. 28 of 1923, of the Administrator of that territory.

2. (a) Enige persoon wat op die 31ste dag van Augustus 1959 die eienaar is van 'n £.s.d.-kasregistermasjien, optel(reken)-masjien of boekhoumasjien wat in die Unie is en wat begerig is om ten opsigte van enige sodanige masjien die omskakelings- of vervangingskompensasie te eis wat deur die Raad bepaal mag word ingevolge paragraaf (a) van artikel vier van die Wet op Desimale Munt, 1959, moet op of voor die 30ste dag van September 1959 of op so 'n later datum as wat die Raad om goeie redes kan toestaan, of self of deur 'n verantwoordelike persoon in sy diens 'n opgawe verstrek aan die masjiennaatskappy waarna in regulasie 3 (a) verwys word, in die vorm aangegee in Bylae A, van elke sodanige masjien wat, toe dit nuut was, in die eerste instansie gelewer is aan die oorspronklike koper, in die geval van—

'n kasregistermasjien..... op na die 1ste Januarie 1939,
'n optel (reken)-masjien..... op na die 1ste Januarie 1946,
'n boekhoumasjien..... op na die 1ste Januarie 1951.

(b) (i) Waar een masjiennaatskappy ingevolge regulasie 3 (a) verantwoordelik is vir meer as een merk van masjien, moet al die merke waarvoor hy verantwoordelik is in 'n enkele opgawe ingesluit word.

(ii) Waar meer as een merk van masjien besit word waarvoor meer as een masjiennaatskappy ingevolge regulasie 3 (a) verantwoordelik is, moet 'n afsonderlike opgawe besorg word aan elke betrokke masjiennaatskappy waarin besonderhede verstrek word van slegs dié masjiene wat op sodanige maatskappy betrekking het.

(c) Waar 'n eienaar 'n persoon of organisasie is wat een of meer takke in bedryf het, moet, onderworpe aan die bepalings van paragraaf (b), slegs een opgawe verstrek word ten opsigte van sodanige persoon of organisasie.

(d) Vir die doeleindes van hierdie regulasies sluit die uitdrukking „eienaar“ in, in die geval van 'n insolvente of bestorwe boedel, die kurator of eksekuteur of administrateur daarvan, of in die geval van 'n maatskappy of koöperatiewe vereniging of koöperatiewe maatskappy in likwidasie, die likwidateur daarvan, of in die geval van 'n maatskappy wat onder geregtelike bestuur is, die geregtelike bestuurder daarvan.

3. (a) Die opgawe moet aangestuur word na die masjiennaatskappy wat ingevolge Bylae B verantwoordelik is vir die meganiese omskakeling van die onderskeie merke van masjiene wat in dié Bylae uiteengesit is of vir die voorlē, namens masjieneienaars, van eise vir die betaling aan eienaars van sodanige vervangingskompensasie as wat deur die Raad bepaal mag word.

(b) Die opgawe moet aangestuur word sodat dit die betrokke masjiennaatskappy bereik nie later nie as die datum waarop, ingevolge regulasie 2 (a), die opgawe aan daardie maatskappy verstrek moet word, en sodanige maatskappy moet ontvangs daarvan erken.

(c) Indien geen erkennung van ontvangs van 'n opgawe ontvang word deur die eienaar binne 21 dae na die afstuur van sodanige opgawe nie, moet sodanige eienaar die betrokke masjiennaatskappy skriftelik van die feit in kennis stel met vermelding van sy volle naam en adres soos in die opgawe aangegee.

4. (a) 'n Opgawe moet masjiene insluit wat op 31 Augustus 1959 onder 'n huurkoopooreenkoms afbetaal word en, vir die doel van hierdie regulasies, sal die huurkoopkoper as die eienaar beskou word; en elke opgawe moet op dieselfde wyse masjiene insluit wat op dié datum gehuur word met 'n opsie om te koop, maar moet nie masjiene insluit nie wat op 31 Augustus 1959 geleent word of gehuur word sonder 'n opsie om te koop.

(b) 'n Masjiene moet as 'n optelmasjien beskou word as dit 'n vaste wa het of 'n wa wat, oor die horizontale, uitsluitlik per hand beweeg word. Waar sodanige beweging van die wa meganies of elektries aangehelp word, moet die masjiene as 'n boekhoumasjien beskou word.

(c) 'n Kasregistermasjien wat bestaan uit 'n optelmasjien op 'n kontantlaai moet, vir die doel van hierdie regulasies as 'n optelmasjien geklassifiseer word en 'n £.s.d.-rekenmasjien moet as 'n optelmasjien geklassifiseer word: Met dien verstande dat slegs dié sodanige rekenmasjiene wat agt of minder vertikale rye £-toetse het, ingesluit moet word in enige opgawe wat ingevolge hierdie regulasies verstrek word.

2. (a) Any person who on the 31st day of August, 1959, is the owner of a £.s.d. cash register machine, adding (calculating) machine or accounting machine located within the Union, and who wishes to claim in respect of any such machine the conversion or replacement compensation which may be determined by the Board in terms of paragraph (a) of section four of the Decimal Coinage Act, 1959, shall on or before the 30th day of September, 1959, or such later date as the Board may for good cause allow, either himself or through a responsible person in his service or employ render to the machine company referred to in regulation 3 (a) a return, in the form set out in Schedule A, of each such machine which, when new, was first supplied to the original buyer, in the case of—

a cash register machine..... on or after the 1st January, 1939,
an adding (calculating) machine..... on or after the 1st January, 1946,
an accounting machine..... on or after the 1st January, 1951.

(b) (i) Where one machine company is in terms of regulation 3 (a) responsible for more than one make of machine, all the makes for which it is responsible shall be included in a single return.

(ii) Where more than one make of machine is owned for which more than one machine company is in terms of regulation 3 (a) responsible, a separate return shall be submitted to each machine company concerned setting out only the particulars of machines pertaining to that company.

(c) Where an owner is a person or organisation operating one or more branches, only one return shall, subject to the provisions of paragraph (b), be rendered in respect of such person or organisation.

(d) For the purposes of these regulations the expression “owner” shall also include, in the case of an insolvent or deceased estate, the trustee or executor or administrator thereof, or in the case of a company or co-operative society or co-operative company in liquidation, the liquidator thereof, or in the case of a company under judicial management, the judicial manager thereof.

3. (a) The return shall be forwarded to the machine company which in terms of Schedule B is responsible for the mechanical conversion of the respective makes of machines set out in that Schedule or for the submission, on behalf of machine owners, of claims for the payment to owners of such replacement compensation as may be determined by the Board.

(b) The return shall be forwarded so as to reach the machine company concerned not later than the date on which, in terms of regulation 2 (a), the return is to be rendered to that company, and such company shall acknowledge receipt thereof.

(c) If no acknowledgement of receipt of a return is received by the owner within 21 days after the dispatch of such return, such owner shall notify the machine company concerned of that fact in writing indicating his full name and address as given in the return.

4. (a) A return shall include machines which were being paid for under hire-purchase agreement on the 31st August, 1959, and, for the purpose of these regulations, the hire-purchase buyer shall be deemed to be the owner; and every return shall likewise include machines which were being rented at that date with an option to purchase but shall not include machines which were on loan or were being rented on the 31st August, 1959, without an option to purchase.

(b) A machine shall be deemed to be an adding machine if it has a fixed carriage or a carriage which is moved horizontally entirely by hand. Where such movement of the carriage is mechanically or electrically assisted, the machine shall be deemed to be an accounting machine.

(c) A cash register machine which consists of an adding machine on a cash drawer shall for the purpose of these regulations be classified as an adding machine and a £.s.d. calculating machine shall be classified as an adding machine: Provided that only such calculating machines as have eight or less vertical rows of £ keys shall be included in any return furnished in terms of these regulations.

5. (a) 'n Eienaar wat 'n opgawe ingevolge hierdie regulasies verstrek het of namens wie 'n opgawe verstrek is en wat gedurende die tydperk 1 September 1959 tot die datum van toevalling van enige omskakelings- of vervangingskompensasie waarna in regulasies 2 (a) en 3 (a) verwys word, enige masjiene wat in enige opgawe ingesluit is, vervreem of enige masjiene wat aldus ingesluit is na 'n ander adres verskuif, moet die betrokke maatskappy skriftelik voorsien van volledige besonderhede van sodanige vervreemding of verandering in plek van gebruik van sodanige masjiene.

(b) Die betrokke masjiene maatskappy moet ontvang van enige sodanige kennisgewing erken en indien sodanige erkenning nie deur die kennisgewer ontvang word binne 21 dae na die afstuur van enige sodanige kennisgewing nie, moet hy die betrokke masjiene maatskappy skriftelik van dié feit verwittig met vermelding van sy volle naam en adres soos in die kennisgewing aangegee.

6. (a) Die eienaar van 'n masjiene waarna in regulasie 2 (a) verwys word, wat in gebreke bly om aan enige bepaling van hierdie regulasies te voldoen, verbeer sy reg tot enige kompensasie wat andersins aan hom mag toegeval het, tensy die Raad in sy diskresie anders bepaal.

(b) Enige persoon wat in of met betrekking tot enige opgawe wat ingevolge hierdie regulasies ingedien word, enige inligting verstrek wat in enige wesenlike besonderheid vals is, met die wete dat dit vals is, begaan 'n misdryf en is by skuldigbevinding strafbaar met tronkstraf van hoogstens twaalf maande of met 'n boete van hoogstens vyfhonderd pond of met beide sodanige tronkstraf en boete.

7. (a) Elke masjiene maatskappy waarna in Bylae B verwys word, moet na ontvang van 'n opgawe wat ingevolge hierdie regulasies ingedien is, met betrekking tot elke masjiene, in die ruimte wat daarvoor verskaf is, die korrekte serie- of fabrieksnommer en die klas-, model- of stylnommer, na gelang van die geval, invloeg, asook, vir sover dit deur die Raad verlang word, die datums van die oorspronklike installering van die betrokke masjiene.

(b) By ontvang van opgawes waarna in paragraaf (a) verwys word, moet die betrokke masjiene maatskappy 'n register, in duplo, in 'n vorm deur die Raad goedgekeur, opstel van alle masjiene wat deur die Raad beskou word as omskakelbaar na 'n desimale grondslag of wat in aanmerking kom vir sodanige vervangingskompensasie as wat deur die Raad bepaal mag word.

(c) Die betrokke masjiene maatskappy moet so gou doenlik die oorspronklike van sodanige register na die Raad deurstuur tesame met die betrokke opgawes wat ingevolge hierdie regulasies ontvang is.

(d) Alle veranderings van eienaars of adresse waar masjiene gebruik word waarvan ingevolge regulasie 5 (a) kennis gegee is, moet volledig, in duplo, deur die betrokke masjiene maatskappy aangeteken word en sal deel uitmaak van die register wat ingevolge regulasie 7 (b) vereis word, en die oorspronklike van die aantekening aldus gemaak moet, so gou doenlik, deur sodanige maatskappy na die Raad deurgestuur word.

8. (a) Elke masjiene maatskappy waarna in Bylae B verwys word, moet tot so 'n datum as wat deur die Raad bepaal mag word, 'n verdere register, in 'n vorm deur die Raad goedgekeur, opstel en byhou, wat volledige besonderhede bevat van alle nuwe £.s.d.-masjiene van die tipes waarna in hierdie regulasies verwys word, wat deur sodanige maatskappy na die 31ste Augustus 1959 in die Unie geland word en van die name en adresse van die persone aan wie sodanige masjiene verkoop, verhuur of geleen word of andersins vervreem word asook die adresse waar sodanige masjiene daarna gebruik word.

(b) Die bepalings van regulasies 5 (a) en (b), 6 (a) en 7 (c) en (d) is *mutatis mutandis* van toepassing op elke masjiene maatskappy en persoon waarna in hierdie regulasies verwys word.

9. Alle opgawes, registers en ander verwante rekords wat ingevolge hierdie regulasies deur 'n masjiene maatskappy gehou word en enige daar mee in verband staande korrespondensie sal te alle tye beskikbaar wees vir inspeksie en verifikasie deur die Raad of enige amptenaar of ander werkneem van die Raad of enige ander persoon wat deur die Raad daartoe gemagtig word of enige regeringsouditeur.

5. (a) An owner who has or on whose behalf a return has been furnished in terms of these regulations and who during the period 1st September, 1959, to the date of accrual of any conversion or replacement compensation referred to in regulations 2 (a) and 3 (a), disposes of any machine included in any return or moves any machine so included to another address, shall furnish the machine company concerned with full particulars in writing of such disposal or change in location of such a machine.

(b) The machine company concerned shall acknowledge the receipt of any such notification and if no such acknowledgement is received by the notifier within 21 days of the dispatch of any such notification, he shall advise the machine company concerned of that fact in writing, indicating his full name and address as given in the notification.

6. (a) The owner of a machine referred to in regulation 2 (a), who fails to comply with any provision of these regulations, shall, unless the Board in its discretion otherwise determines, forfeit his right to any compensation which might otherwise have accrued to him.

(b) Any person who in or in relation to any return rendered in terms of these regulations, furnishes any information which is false in any material particular, knowing the same to be false, shall be guilty of an offence and liable, on conviction, to imprisonment for a term not exceeding twelve months or to a fine not exceeding five hundred pounds or to both such imprisonment and fine.

7. (a) Every machine company referred to in Schedule B shall, upon receipt of a return rendered in terms of these regulations in respect of each machine insert in the space provided therefor the correct serial or factory number and class, model or style number, as the case may be, and, in so far as may be required by the Board, the dates of the original installation of the machines concerned.

(b) Upon receipt of returns referred to in paragraph (a), the machine company concerned shall establish a register, in duplicate, in a form approved of by the Board, of all machines deemed by the Board to be convertible to a decimal basis or eligible for such replacement compensation as may be determined by the Board.

(c) The machine company concerned shall as soon as practicable transmit to the Board the original of such register together with the relevant returns received in terms of these regulations.

(d) All changes of ownership or location of machines notified in terms of regulation 5 (a) shall be fully recorded, in duplicate, by the machine company concerned and shall form part of the register required in terms of regulation 7 (b), and the original of the record so made shall, as soon as practicable, be transmitted to the Board by such company.

8. (a) Every machine company referred to in Schedule B shall establish and maintain, until such date as may be determined by the Board, a further register, in a form approved of by the Board setting out full particular of all new £.s.d. machines of the types referred to in these regulations which are landed by such company within the Union after the 31st August, 1959, and the names and addresses of the persons to whom such machines are sold, hired out, loaned or otherwise disposed of as also the addresses where such machines are thereafter located.

(b) The provisions of regulations 5 (a) and (b), 6 (a) and 7 (c) and (d) shall *mutatis mutandis* apply to every machine company and person referred to in this regulation.

9. All returns, registers and other related records kept by a machine company in terms of these regulations and any correspondence in connection therewith, shall at all times be open for inspection and verification by the Board or any officer or other employee of the Board or any other person duly authorised thereto by the Board or any Government auditor.
