PRODUCERS' PRICES FOR OFFAL IN  
CONTROLLED AREAS.

In terms of section *twenty-nine* of the Marketing Act, 1937 (Act No. 26 of 1937), as amended, I, DIRK CORNELIS HERMANUS UYS, Minister of Agricultural Economics and Marketing, hereby make known that the Livestock and Meat Industries Control Board, referred to in section 3 of the Livestock and Meat Control Scheme, published by Proclamation No. 265 of 1945, as amended, has, under the powers vested in it by section 14 of the said Scheme, with my approval imposed the prohibitions and made the determinations set out in the Schedule hereto in substitution of Government Notice No. 1302 of 1953, as amended, which is hereby repealed.

SCHEDULE.

1. In this Schedule, any expression to which a meaning has been assigned in the Livestock and Meat Control Scheme, published by Proclamation No. 265 of 1945, as amended, shall have the meaning so thereto assigned: Further unless inconsistent with the context—

“controlled area” shall mean any area specified in Schedule I to Government Notice No. 1429 of 1959, which shall, in terms of a decision of the Board be an area to which the provisions of this Schedule shall apply;

“detained offal” shall mean offal which is passed by a recognised health inspector as fit for human consumption subject to treatment in terms of the Public Health Act, 1919, or any regulation made thereunder;

“dressed carcass” shall mean the carcass or any part or portion thereof derived from a slaughter animal after the hide or skin (or the hair in the case of pigs), the entrails, the pluck, the shanks and the head (in the case of cattle, sheep and goats), the lactating udder in the case of cows, and, in the case of cattle, also the diaphragm and its pillars (i.e. the thick skirt) and the tail, have been removed;

“offal” shall mean all portions of a slaughter animal (other than the hide or skin) which do not form part of the dressed carcass;

“sound offal” shall mean offal which is passed by a recognised health inspector as fit for human consumption without treatment in terms of the Public Health Act, 1919, or any regulations made thereunder;

“producer” means the owner of a slaughter animal at the time of slaughtering thereof;

Kragtens artikel *nege-en-twintig* van die Bemerkingswet, 1937 (Wet No. 26 van 1937), soos gewysig, maak ek, DIRK CORNELIS HERMANUS UYS, Minister van Landbou-ekonomie en -bemarking, hierby bekend dat die Raad van Beheer oor die Vee- en Vleisnywerhede, vermeld in artikel 3 van die Vee- en Vleisreëlinskema, gepubliseer by Proklamasie No. 265 van 1945, soos gewysig, kragtens die bevoegdheid hom verleen by artikel 14 van genoemde Skema met my goedkeuring die verbodsbepalings opgelê en die vasstellings gedoen het wat in die Bylae hiervan uiteengesit is ter vervanging van Goewermentskennisgewing No. 1302 van 1953, soos gewysig, wat hierby herroep word.

BYLAE.

1. In hierdie Bylae het 'n uitdrukking waaraan 'n betekenis geheg is in die Vee- en Vleisreëlinskema, gepubliseer by Proklamasie No. 265 van 1945, soos gewysig, die betekenis aldus daaraan geheg: Voorts, tensy dit in stryd is met die samehang, beteken—

„beheerde gebied”, 'n gebied in Bylae I van Goewermentskennisgewing No. 1429 van 1959 uiteengesit, wat kragtens 'n besluit van die Raad 'n gebied waarop die bepaling van hierdie Bylae van toepassing is;

„teruggehoue afval”, afval wat deur 'n erkende gesondheidsinspekteur goedgekeur is as geskik vir menslike verbruik onderhewig aan behandeling ooreenkomstig die Volksgezondheidswet, 1919, of regulasies daarkragtens uitgevaardig;

„gedresseerde karkas”, die karkas of 'n deel of gedeelte daarvan, afkomstig van slagvee nadat die huid of vel (of die hare in die geval van varke), die binnegoed, die harslag, die skenkels en die kop (in die geval van beeste, skape en bokke), die uier (in die geval van 'n koei wat in die melk is), en, in die geval van beeste die mantelvlies met die dikvlies daarvan en die stert, verwyder is;

„afval”, alle gedeeltes van slagvee (behalwe die huid of vel) wat nie deel van die gedresseerde karkas uitmaak nie;

„gesonde afval”, afval wat deur 'n erkende gesondheidsinspekteur goedgekeur is as geskik vir menslike verbruik sonder behandeling ooreenkomstig die Volksgezondheidswet, 1919, of regulasies daarkragtens uitgevaardig;

„produsent”, die eienaar van slagvee ten tyde van die slag daarvan;

"rate" means the amount in shillings and pence per 100 lb. dressed carcase weight specified in the Annexure hereto as the basis for calculating the producer price of offal.

2. No producer of slaughter animals shall in any controlled area sell sound or detained offal at a price other than—

- (a) a price calculated in accordance with the weight of the dressed carcase of the animal from which the offal is derived at the rate specified in the Annexure hereto for such offal in respect of that controlled area; or
- (b) the price per individual item of offal likewise specified.

## DECIDUOUS FRUIT SCHEME.

## REGISTERED DISTRIBUTORS' BUYING AND SELLING PRICES FOR DECIDUOUS FRUIT.

In terms of sub-section (1) of section *twenty-nine* of the Marketing Act, 1937 (Act No. 26 of 1937), as amended, I, DIRK CORNELIUS HERMANUS UYS, Minister of Agricultural Economics and Marketing, hereby make known that the Deciduous Fruit Board referred to in section 3 of the Deciduous Fruit Scheme, published under Proclamation No. 134 of 1951, as amended, has, in terms of section 22 *bis* of that scheme, and with my approval, imposed the prohibition specified in the Schedule hereto in connection with the acquisition and sale of deciduous fruit by registered distributors.

"tarief", die bedrag in sjielings en pennies per 100 lb. gedresseerde karkasgewig wat in die Aanhangsel hiervan gespesifiseer is as die grondslag vir berekening van die produsenteprys van afval.

2. Geen produsent van slagvee mag gesonde of teruggehoue afval in 'n beheerde gebied teen 'n ander prys verkoop as—

- (a) 'n prys bereken volgens die gewig van die gedresseerde karkas van die dier waarvan die afval afkomstig is teen die tarief wat in die Aanhangsel hiervan ten opsigte van daardie beheerde gebied vir daardie afval gespesifiseer is; of

## SAGTEVRUGTESKEMA.

## GEREGISTREERDE DISTRIBUEERDERS SE KOOP- EN VERKOOPPRYSE VIR SAGTEVRUGTE.

Ingevolge subartikel (1) van artikel *nege-en-twintig* van die Bemarkingswet, 1937 (Wet No. 26 van 1937), soos gewysig, maak ek, DIRK CORNELIUS HERMANUS UYS, Minister van Landbou-ekonomie en -bemarking, hierby bekend dat die Sagtevrugteraad genoem in artikel 3 van die Sagtevrugteskema afgekondig by Proklamasie No. 134 van 1951, soos gewysig, kragtens artikel 22 *bis* van daardie skema en met my goedkeuring, die verbod in die Bylae hiervan uiteengesit, opgelê het in verband met die verkryging en verkoop van sagtevrugte deur geregistreerde distribueerders.

And, I do hereby further make known that the said prohibition shall become operative on the date of publication hereof and shall remain in force until the 31st day of October, 1960.

SCHEDULE.

1. No person dealing in the course of trade with deciduous fruit, who has been registered with the Board in terms of section 22 of the Scheme, shall—

- (a) acquire from producers of deciduous fruit any plums, prunes, peaches, nectarines, grapes or pears produced in the controlled area, at prices below the prices specified in column 3 of the table hereunder for the respective kind, grade, pack or quantity of fruit;
- (b) sell in the registration area any plums, prunes, peaches, nectarines, grapes or pears produced in the controlled area, at prices other than the prices specified in column 4 or 5 as the case may be, of the table hereunder for the respective kind, grade, pack or quantity of fruit.

- (a) enige, pruime, pruimedante, perskes, kaalperskes, druive of pere wat in die beheerde gebied geproduseer is, teen laer pryse as dié gespesifiseer in kolom 3 van die tabel hieronder vir die onderskeie soort, graad, verpakking of hoeveelheid vrugte, van produsente van sagtevrugte verkry nie;
- (b) in die registrasiegebied enige pruime, pruimedante, perskes, kaalperskes, druive of pere wat in die beheerde gebied geproduseer is, teen ander pryse verkoop nie as dié in kolom 4 of 5, na gelang van die geval, van die tabel hieronder gespesifiseer vir die onderskeie soort, graad, verpakking of hoeveelheid vrugte.

2. The prices specified in clause 1 are subject to the following conditions:—

- (a) The prices referred to in paragraph (a) of clause 1 are free on rail, producers' nearest railway loading station or siding or road motor service halt;
- (b) with effect from the 1st April, 1960, the following charges must be added to the prices referred to in paragraph (b) of clause 1 in respect of cold storage whenever the pears have been kept in cold stores:—

Trays: 4½d. per tray per month.  
Cases: 1s. per case per month.

“controlled area” means any of the following areas:—

The Districts of Bellville, Caledon, Ceres, George, Humansdorp, Knysna, Malmesbury, Montagu, Paarl, Piketberg, Robertson, Somerset West, Stellenbosch, Swellendam, Tulbagh, Uniondale, Wellington, Worcester and Wynberg;

“producer” has the meaning assigned to it in section 2 of the Scheme;

“registration area” means the Union, excluding the controlled area and the marketing area as defined in the Scheme;

“Scheme” means the Deciduous Fruit Scheme promulgated under Proclamation No. 134 of 1951, as amended; and

the fruit referred to in this Schedule shall be the varieties to which the Schedule to Government Notice No. 2089 of 1956 (“Prohibition on the sale of Deciduous Fruit”), as amended, applies.

## DECIDUOUS FRUIT SCHEME.

## LEVY ON DECIDUOUS FRUIT.

In terms of sub-section (1) of section *twenty-nine* of the Marketing Act (Act No. 26 of 1937), as amended, I, DIRK CORNELIS HERMANUS UYS, Minister of Agricultural Economics and Marketing, hereby make known that the Deciduous Fruit Board, referred to in section 3 of the Deciduous Fruit Scheme, published under Proclamation No. 134 of 1951, as amended, has, in terms of section 18 of the said Scheme and with my approval, imposed the levy on deciduous fruit as set out in the Schedule hereto, in substitution of the levy made known by Government Notice No. 24 of 2nd January, 1959.

And I do hereby further make known that the said levy shall come into operation on the date of publication hereof. Government Notice No. 24 of 2nd January, 1959, is hereby withdrawn.

## SCHEDULE.

1. There is hereby imposed a levy—

(a) at the rate of one and a half per cent of the selling price realised in respect of apricots, peaches and nectarines, plums and prunes, pears, grapes and apples exported from the Union for the purpose of sale;

(b) at the rate of one and a half per cent of the selling price realised in respect of—

(i) grapes of the varieties set out in the Annexure to Government Notice No. 2089 of 9th November, 1956, produced in the controlled area and sold within the Union excluding the controlled area and the Cape Town area of the marketing area, for consumption to a fresh state;

(ii) all freestone peaches (both white and yellow fleshed), nectarines and prunes produced in the controlled area and sold within the Union, excluding the controlled area and the Cape Town and Port Elizabeth areas of the marketing areas, for consumption in a fresh state;

Die distrikte Bellville, Caledon, Ceres, George, Humansdorp, Knysna, Malmesbury, Montagu, Paarl, Piketberg, Robertson, Somerset-Wes, Stellenbosch, Swellendam, Tulbagh, Uniondale, Wellington, Worcester en Wynberg;

„produzent”, dieselfde as in artikel 2 van die skema;

„registrasiegebied”, die Unie, uitgesonderd die beheerde gebied en die bemarkingsgebied soos in die skema omskryf;

„skema”, die sagtevrugteskema afgekondig by Proklamasie No. 134 van 1951, soos gewysig; en

Kragtens subartikel (1) van artikel *nege-en-twintig* van die Bemerkingswet (Wet No. 26 van 1937), soos gewysig, maak ek, DIRK CORNELIS HERMANUS UYS, Minister van Landbou-ekonomie en -bemarking, hierby bekend dat die Sagtevrugteraad, genoem in artikel 3 van die Sagtevrugteskema, afgekondig by Proklamasie No. 134 van 1951, soos gewysig, kragtens artikel 18 van genoemde Skema en met my goedkeuring die heffing op sagtevrugte opgelê het soos uiteengesit in die Bylae hiervan, ter vervanging van die heffing bekendgemaak by Goewermentskennisgewing No. 24 van 2 Januarie 1959.

En voorts maak ek hierby bekend dat genoemde heffing op die datum van bekendmaking hiervan in werking tree. Goewermentskennisgewing No. 24 van 2 Januarie 1959 word hierby herroep.

## BYLAE.

1. Hierby word 'n heffing opgelê—

(a) teen die koers van een en 'n half persent van die verkoopprijs behaal ten opsigte van appelkose, perskes en kaalperskes, pruime en pruimedante, pere, druwe en appels wat vir verkoop uit die Unie uitgevoer word;

(b) teen die koers van een en 'n half persent van die verkoopprijs behaal ten opsigte van—

(i) druwe van die variëteite uiteengesit in die Aanhangsel by Goewermentskennisgewing No. 2089 van 9 November 1956, geproduseer in die beheerde gebied en verkoop in die Unie met uitsondering van die beheerde gebied en die Kaapstad-gebied van die bemarkingsgebied, vir verbruik as vars vrugte;

(ii) alle lospitperskes (beide wit- en geelvlies), kaalperskes en pruimedante geproduseer in die beheerde gebied en verkoop in die Unie met uitsondering van die beheerde gebied en die Kaapstad- en Port Elizabeth-gebied van die bemarkingsgebied, vir verbruik as vars vrugte;

(iii) plums and pears produced in the controlled area and sold in the Union or processed (excluding the drying of such plums and pears) in the course of trade by the producers thereof, excluding plums and pears sold in the controlled area and the Cape Town and Port Elizabeth areas of the marketing area for consumption in a fresh state.

2. In this notice any expression to which a meaning has been assigned in the Marketing Act (Act No. 26 of 1937), as amended, bears the same meaning; further, unless inconsistent with the context—

“producer” has the meaning assigned to it in section 2 of the said Deciduous Fruit Scheme;

“controlled area” and the “Cape Town and Port Elizabeth areas of the marketing area” shall have the same meaning assigned thereto in section 2 of the said Deciduous Fruit Scheme;

“fruit sold for consumption in a fresh state” means fruit sold to any person other than a processor thereof;

“selling price” for pears and plums processed in the course of trade by a producer thereof (excluding the drying of such plums and pears) means the selling price per ton formally negotiated between the Deciduous Fruit Board on the one hand and the South African Fruit and Vegetable Canners' Association (Proprietary), Limited, on the other hand, for each of the relevant varieties, or group varieties, grades and sizes; provided that where no such selling price is so negotiated in respect of a particular season, “selling price” shall mean the weighted average of the said Board's selling prices in the Union for plums or pears sold for processing in the course of trade (excluding drying or processing), for each of the relevant varieties or group of varieties, grades and sizes.


