PRICE CONTROL.

MAXIMUM PRICES OF MILK.

In terms of War Measure No. 49 of 1946, I, Johannes Jacobus Kitshoff, Deputy Price Controller, acting by virtue of the powers assigned to me by the Price Controller in terms of regulation 1 of the said War Measure, hereby amend Government Notice No. 1801 of the 28th November, 1958 (maximum prices of milk)—

(a) by substituting the following new paragraph for the existing paragraph 1 (3):—

1. (3) The maximum price at which fresh milk may be sold to a distributor at Durban or Pietermaritzburg by a producer or may be purchased by such a distributor from a producer is two shillings and elevenpence per 10·3 lb. in the case of milk delivered in cans and two shillings and eleven and one halfpenny per 10·3 lb. in the case of milk delivered in bulk per tank car,

and

(b) by substituting Part E—Pietermaritzburg, and Part H—Durban, as specified in the Schedules hereto for the corresponding Schedules thereto, with effect from the 1st November, 1959.

NOTE.—The effect of this Notice is to increase in certain cases, the maximum prices of fresh milk in Pietermaritzburg and Durban.

Ek, Johannes Jacobus Kitshoff, Adjunk-pryskontroleur, handelende kragtens die bevoegdheid my verleen deur die Pryscontroleur kragtens regulasie 1 van Oorlogsmaatreël No. 49 van 1946, wysig hierby, kragtens genoemde Oorlogsmaatreël, Goewermentskennisgewing No. 1801 van 28 November 1958 (maksimum pryse van melk)—

(a) deur die bestaande paragraaf 1 (3) te vervang met die volgende nuwe paragraaf:—

1. (3) Die maksimum prys waarteen vars melk in Durban of Pietermaritzburg deur 'n produsent aan 'n distribueerder verkoop mag word of deur 'n distribueerder van 'n produsent gekoop mag word, is twee sjelings en elf pennies per 10·3 lb. in die geval van melk wat in kanne gelewer word en twee sjelings en elf en 'n halfpennie per 10·3 lb. in die geval van melk wat by die groot maat per tenkwa gelewer word.

(b) deur Bylae E—Pietermaritzburg en Bylae H—Durban, soos in die Bylaes hiervan gespesifiseer in die plek te stel van die ooreenstemmende dele van die Bylaes daarvan met ingang van 1 November 1959.
