PRODUCER PRICES FOR OFFAL IN CONTROLLED AREAS.—AMENDMENT.

In terms of section *twenty-nine* of the Marketing Act, 1937 (Act No. 26 of 1937), as amended, I, DIRK CORNELIS HERMANUS UYS, Minister of Agricultural Economics and Marketing, hereby make known that the Livestock and Meat Industries Control Board, referred to in section 3 of the Livestock and Meat Control Scheme, published by Proclamation No. 265 of 1945, as amended, has, under the powers vested in it by section 14 of the said Scheme, with my approval further amended the determinations set out in the Schedule to Government Notice No. 1825 of 1959, as amended, in the manner set out in the Schedule hereto.

And I hereby further make known that this notice shall come into operation on the 14th March, 1960.

SCHEDULE.

The Schedule to Government Notice No. 1825 of 1959, as amended, is hereby further amended by—

- (1) increasing the rate for sound cattle offal as specified in clause 1 of the Annexure for the Durban controlled area, from 9s. 6d. to 10s.
- (2) increasing the rate for sound lamb, sheep and goat offal as specified in clause 1 of the Annexure for the Durban controlled area, from 11s. to 11s. 6d.
