APPOINTMENT OF COMMISSION OF ENQUIRY INTO THE EVENTS IN THE DISTRICTS OF VEREENIGING (AT SHARPEVILLE LOCATION AND EVATON) AND VANDERBIJLPARK, PROVINCE OF THE TRANSVAAL, ON 21st MARCH, 1960.

It is hereby notified for general information that His Excellency the Governor-General has been pleased to appoint a Commission of Enquiry consisting of the Honourable Petrus Johannes Wessels, Judge of the Natal Provincial Division of the Supreme Court of South Africa, who will also be the chairman, with the following terms of reference:—

To enquire into the events in the Districts of Vereeniging (at Sharpeville Location and Evaton) and Vanderbijlpark, Province of the Transvaal, on 21st March, 1960.

The Commission will commence its sittings at the Magistrate's Court, Vereeniging, at 10 a.m. on Monday, 11th April, 1960.

Interested persons who desire to make representations to or give evidence before the Commission should communicate with the Secretary of the Commission, c/o Room 7, Supreme Court Building, Johannesburg, and must submit to the Secretary in writing a summary of such representations or evidence.
