APPLICATION OF REGULATION 9 OF THE  
EMERGENCY REGULATIONS.

WHEREAS I, FRANCOIS CHRISTIAAN ERASMUS, Minister of Justice for the Union of South Africa, am satisfied on examination of the publications *The Torch* and *New Age* published respectively by the Proprietors, The Torch Printing and Publishing Co. (Pty.) Ltd. and by Real Printing and Publishing Co. (Pty.) Ltd. that there is in the said publications a systematic publishing of matter which is, in my opinion, of a subversive character;

NOW THEREFORE by virtue of the powers vested in me by sub-regulation (1) of Regulation 9 of the Emergency Regulations promulgated under Proclamation No. 91 dated the 30th March, 1960, I hereby apply by order the provisions of the said Regulation 9 to the aforesaid publications published by the said Proprietors, The Torch Printing and Publishing Co. (Pty.) Ltd and by Real Printing and Publishing Co. (Pty.) Ltd. respectively.
