CALL OUT AND MOBILIZATION OF PORTION OF THE CITIZEN FORCE.

UNDER the powers vested in me by sub-section (1) of section *ninety-two* of the Defence Act, 1957 (Act No. 44 of 1957), I hereby call out and mobilize the units of the Citizen Force named in the subjoined schedule for service in the prevention or suppression of internal disorder in the Union or in the preservation of life, health or property or the maintenance of essential services and I hereby command every member of each of such Citizen Force units to report personally for such service at a time and place determined and appointed by the Commandant-General, South African Defence Force, or any other officer authorized thereto by him, *but not before such time and place have been so determined and appointed*.

ALGEMENE REGULASIES VIR DIE SUID-AFRIKAANSE WEERMAG EN DIE RESERVE.

DIT HET Sy Eksellensie die Goewerneur-generaal behaag om, kragtens die bepalings van paragraaf (s) van sub-artikel (1) van artikel *sewe-en-tig* saamgelees met paragraaf (j) van sub-artikel (1) van artikel *sewe-en-negentig* en sub-artikels (2) en (3) van artikel *agt-en-negentig* van die Verdedigingswet, 1957 (Wet No. 44 van 1957), die volgende regulasies uit te vaardig:

VRYSTELLING VAN DIENS.

1. Niemand kan ingevolge artikel *een-en-negentig* of *twee-en-negentig* van die Verdedigingswet, 1957 (Wet No. 44 van 1957), vir diens opgeroep word nie indien hy—

- in die voltydse diens van enige plaaslike bestuur is of regstreeks verbonde is aan enige brandweer-diens van so 'n bestuur;
- 'n verpleer in enige hospitaal is of
- 'n manlike tegnikus is wat by of met enige erkende bloedoortappingsdiens of tak daarvan diens as sodanig verrig.

SAMESTELLING VAN VRYSTELLINGSRAAD.

- (1) Enige vrystellingsraad deur die Minister kragtens sub-artikel (1) van artikel *agt-en-negentig* van die Verdedigingswet, 1957 (Wet No. 44 van 1957), aangestel, bestaan uit hoogstens ses lede met inbegrip van die voorsitter waarvan een deur die Sekretaris van Arbeid uit die beampies van sy Departement benoem word.
- (2) Die sekretariële pligte verbonde aan die verrigtinge en werksaamhede van enige sodanige raad word verrig deur 'n offisier van die Suid-Afrikaanse Weermag wat vir dié doel deur die Adjudant-generaal aangewys word.

BY VIRTUE of the powers vested in me by sub-section (1) of section *one* of the Unlawful Organizations Act, 1960 (Act No. 34 of 1960), I hereby declare the body known as the PAN AFRICANIST CONGRESS and the body known as the AFRICAN NATIONAL CONGRESS, including all branches, sections or committees thereof, and all local, regional or subsidiary bodies forming part thereof, to be unlawful organizations.

This Proclamation shall remain in force until the Sixth day of April, 1961.

GENERAL REGULATIONS FOR THE SOUTH AFRICAN DEFENCE FORCE AND THE RESERVES.

His Excellency the Governor-General has been pleased in terms of paragraph (s) of sub-section (1) of section *eighty-seven* read with paragraph (j) of sub-section (1) of section *ninety-seven* and sub-sections (2) and (3) of section *ninety-eight* of the Defence Act, 1957 (Act No. 44 of 1957), to make the following regulations:

EXEMPTION FROM SERVICE.

1. No person shall be liable to be called out for service in terms of section *ninety-one* or *ninety-two* of the Defence Act, 1957 (Act No. 44 of 1957), if he is—

- in the full-time employ of any local authority or in direct association with any fire-brigade service of such authority;
- a male nurse in any hospital or
- a male technician performing service as such or with any recognized blood transfusion service or branch thereof.

CONSTITUTION OF EXEMPTION BOARD.

- (1) Any exemption board appointed by the Minister under sub-section (1) of section *ninety-eight* of the Defence Act, 1957 (Act No. 44 of 1957) shall consist of not more than six members including the chairman one of whom shall be nominated by the Secretary for Labour from among the officials of his Department.
- (2) The secretarial duties connected with the proceedings and functions of any such board shall be performed by an officer of the South African Defence Force designated for the purpose by the Adjutant-general.
