## PROCLAMATION.

WHEREAS in my opinion it appears that circumstances have arisen in the areas specified in the attached Schedule which seriously threaten the safety of the public and the maintenance of public order, and the ordinary law of the land is inadequate to enable the Government to ensure the safety of the public and to maintain public order.

NOW THEREFORE, acting under the powers vested in me by Section *two* of the Public Safety Act, 1953 (Act No. 3 of 1953), I hereby declare that a state of emergency exists within the areas specified in the attached Schedule as from the 9th April, 1960.

## PROCLAMATION.

WHEREAS a state of emergency has been declared in terms of section *two* of the Public Safety Act, 1953 (Act No. 3 of 1953), to exist within the areas specified in Schedule A hereto as from the 9th April, 1960; and

WHEREAS I deem it necessary and expedient to provide by regulation for the safety of the public, the maintenance of public order, the termination of the said state of emergency and for dealing with circumstances which in my opinion have arisen or are likely to arise as a result of the said state of emergency;

So is dit dat ek kragtens die bevoegdheid my verleen by artikel *drie* van die Wet op Openbare Veiligheid, 1953 (Wet No. 3 van 1953), soos gewysig, die regulasies in Bylae B vervat, uitvaardig om in gemelde gebiede van toepassing te wees en kragtens paragraaf (b) van sub-artikel (2) van die bedoelde artikel verklaar dat, behoudens die bepalings van regulasie *ses-en-twintig*, die voormalde regulasies geag word op die 9de April 1960 in werking te getree het.

#### BYLAE B

#### NOODTOESTAND-REGULASIES.

Die Noodtoestand-regulasies uitgevaardig kragtens die bepalings van artikel *drie* van die Wet op Openbare Veiligheid, 1953 (Wet No. 3 van 1953) en aangekondig by Proklamasie No. 91 gedateer 30 Maart 1960, soos gewysig by Proklamasie No. 97 gedateer 2 April 1960, is van toepassing ook met betrekking tot die gebiede in Bylae A van hierdie Proklamasie vermeld.

NOW THEREFORE, acting under the powers vested in me by section *three* of the Public Safety Act, 1953 (Act No. 3 of 1953), as amended, I hereby make the regulations contained in Schedule B hereto to be of force and effect in the said areas, and in terms of paragraph (b) of subsection (2) of the said section I hereby declare that subject to the provisions of regulation *twenty-six* the said regulations shall be deemed to have come into operation on the 9th April, 1960.
