CUSTOMS ACT, 1955.—AMENDMENT OF THE  
SECOND SCHEDULE (No. 2/30).

I, THEOPHILUS EBENHAEZER DÖNGES, Minister of Finance, acting in terms of the powers vested in me by section ninety-eight of the Customs Act, 1955, hereby amend the Second Schedule to the said Act to the extent set out in the Schedule hereto.

**SCHEDULE.**

Item.	Article.	Duty rebated as under.
409	By substituting for the item the following:—	
" 409	Beer brewing and malt manufacturing industry—	
	(1) Malted barley, in such quantities and at such times as may be permitted by the Minister, for the brewing of beer.	To the extent of the intermediate duty.
	(2) Barley, in such quantities and at such times as may be permitted by the Minister, for the manufacture of malted barley for the brewing of beer or for export	To the extent of the intermediate duty".

NOTE.—The effect of this notice is that, with effect from the date of publication hereof, barley may be imported or taken out of bond under rebate of duty by registered manufacturers for use in the manufacture of malted barley for export.

	(2) Gars, in sodanige hoeveelhede en op sodanige tye as wat deur die Minister toegelaat mag word, vir die vervaardiging van gemoute gars vir die brou van bier of vir uitvoer.	Tot die bedrag van die intermediêre reg”.
