MAXIMUM PRICES OF KRAAL MANURE AND COMPOST.

In terms of War Measure No. 49 of 1946, I, Gabriel Joseph Johannes Fourie Steyn, Deputy Price Controller, acting by virtue of the powers assigned to me by the Price Controller in terms of regulation 1 of the said War Measure, hereby withdraw Government Notice No. 1072 of 25th July, 1958.

PRICE CONTROL.

MAXIMUM PRICES OF GROCERIES.

In terms of War Measure No. 49 of 1946, I, Gabriel Joseph Johannes Fourie Steyn, Deputy Price Controller, acting by virtue of the powers assigned to me by the Price Controller in terms of regulation 1 of the said War Measure, hereby further amend Government Notice No. 1069 of the 25th July, 1958, by prescribing that all prices as contained in Item No. 3 (Sugar) in the Second Schedule thereto and in Item No. 3 (Sugar) in the Third Schedule thereto, may be increased by $\frac{1}{2}$ d. per pound, with effect from the 25th November, 1960.
