## REGULATIONS IN TERMS OF THE DECIMAL COINAGE ACT, 1959.

His Excellency the Governor-General, under the powers conferred upon him by paragraph (b) of subsection (1) of section *eight* of the Decimal Coinage Act, 1959 (Act No. 61 of 1959), has made the following regulation:—

### AMENDMENT OF REGULATIONS PUBLISHED UNDER GOVERNMENT NOTICE NO. 1857 DATED 18TH NOVEMBER, 1960.

Regulation 1 of the Regulations published under Government Notice No. 1857 dated 18th November, 1960, is hereby amended by the insertion after paragraph (a) of the following paragraph—

“(a)*bis*. The Commissioner for Inland Revenue may direct that any office or part of any office under his control shall be closed to the public on the thirteenth day of February, 1961, for the purpose of preparing for the commencement of sections *one* and *two* of the Decimal Coinage Act, 1959 (Act No. 61 of 1959).”

## REGULASIES KRAGTENS DIE WET OP DESIMALE MUNT, 1959.

### WYSIGING VAN REGULASIES BY GOEWERMENTS-KENNISGEWING NO. 1857 VAN 18 NOVEMBER 1960 AFGEKONDIG.

Regulasie 1 van die Regulasies by Goewerments-kennisgewing No. 1857 van 18 November 1960 afgekondig, word hierby gewysig deur na paragraaf (a) die volgende paragraaf in te voeg—

“(a)*bis*. Die Kommissaris van Binnelandse Inkomste kan gelas dat 'n kantoor of gedeelte van 'n kantoor onder sy beheer op die dertiende dag van Februarie 1961 ter voorbereiding vir die inwerkingtreding van artikels *een* en *twee* van die Wet op Desimale Munt, 1959 (Wet No. 61 van 1959), vir die publiek gesluit moet word.”
