IT IS HEREBY notified for general information that His Excellency the Officer Administering the Government has been pleased to appoint a Commission of Enquiry consisting of Mr. Norman Patrick Joseph O'Connell, Permanent Member of the Central Native Appeal Court, who will also be the chairman, with the following terms of reference:

To enquire into and report upon:—

- (i) the events in the Warmbaths location in the town of Warmbaths, District of Warmbaths, Province of Transvaal, on the 28th, 29th and 30th April, 1961;
- (ii) the grievances, if any, of the Native inhabitants of the Warmbaths location and to what extent such grievances led to the events of the 28th, 29th and 30th April, 1961; and any other matter relevant to these events;
- (iii) the management of the department of Native Administration of the urban local authority of Warmbaths in all its aspects and the activities of all officers of that department, licensed in terms of subsection (1) of section *twenty-two* of the Natives (Urban Areas) Consolidation Act, No. 25 of 1945, as amended, in the performance of their duties and the relations between such officers and—
 - (a) the Native inhabitants of the Warmbaths location, and
 - (b) the Town Council of Warmbaths,
 during the period 1st January, 1957, to the 30th April, 1961.

The Commission will commence its sittings in the Court Room, Magistrate's Office, Warmbaths, at 10 a.m. on Monday, 15th May, 1961.

- (ii) die griewe, indien enige, van die Naturelle inwoners van die Warmbad-lokasie en tot watter mate sodanige griewe gelei het tot die gebeure van 28, 29 en 30 April 1961; en enige ander aangeleentheid wat ter sake is tot die gebeure;
- (iii) al die aspekte van die bestuur van die afdeling Naturelle-administrasie van die stedelike plaaslike bestuur van Warmbad en die bedrywighede van alle amptenare van daardie Afdeling wat kragtens subartikel (1) van artikel *twee-en-twintig* van die Naturelle (Stadsgebiede) Konsolidasiewet, No. 25 van 1945, soos gewysig, gelisensieer is, in die uitvoer van hulle pligte en die verhoudinge tussen sodanige amptenare en—
 - (a) die Naturelle inwoners van die Warmbad-lokasie, en
 - (b) die Stadsraad van Warmbad,
 gedurende die tydperk 1 Januarie 1957, tot 30 April 1961.
