TOBACCO CONTROL SCHEME.

LEVY AND SPECIAL LEVY ON TOBACCO.

In terms of section *twenty-nine* of the Marketing Act, 1937 (Act No. 26 of 1937), as amended, I, DIRK CORNELIS HERMANUS UYS, Minister of Agricultural Economics and Marketing, do hereby make known that the Tobacco Industry Control Board, referred to in section 3 of the Tobacco Control Scheme, published under Proclamation No. 51 of 1939, as amended, has, in terms of sections 18 and 19 of that Scheme and with my approval, imposed, with effect from the date of publication hereof, the following levies on tobacco, in substitution of the levy and special levy made known by Government Notice No. 507 of the 3rd April, 1959:—

- (a) A levy at the rate of fifteen cents (15c) per hundred pounds in respect of all classes and grades of tobacco;
- (b) a special levy at the rate of—
 - (i) three rand eighty-five cents (R3.85) per hundred pounds in respect of all grades of flue-cured tobacco;
 - (ii) two rand sixty cents (R2.60) per hundred pounds in respect of all grades of light air-cured and light Burley tobacco;
 - (iii) one rand and eighty-five cents (R1.85) per hundred pounds in respect of all grades dark air-cured roll, snuff and fire-cured snuff tobacco; and
 - (iv) one rand thirty-five cents (R1.35) per hundred pounds in respect of all grades Turkish tobacco, dark air-cured pipe tobacco, dark Burley tobacco, dark fire-cured pipe tobacco, cigar tobacco and Transkeian tobacco.

HEFFING EN SPESIALE HEFFING OP TABAK.

Ingevolge artikel *nege-en-twintig* van die Bemerkingswet, 1937 (Wet No. 26 van 1937), soos gewysig, maak ek, DIRK CORNELIS HERMANUS UYS, Minister van Landbou-ekonomie en -bemarking, hierby bekend dat die Raad van Beheer oor die Tabaknywerheid, genoem in artikel 3 van die Tabakreelingskema, gepubliseer by Proklamasie No. 51 van 1939, soos gewysig, ingevolge artikels 18 en 19 van daardie Skema, en met my goedkeuring, die volgende heffings met ingang van die datum van publikasie hiervan op tabak opgelê het ter vervanging van die heffing en spesiale heffing bekendgemaak by Goewermentskennisgewing No. 507 van 3 April 1959:—

- (a) 'n Heffing teen 'n tarief van vyftien sent (15c) per honderd pond ten opsigte van alle klasse en grade van tabak;
- (b) 'n spesiale heffing teen 'n tarief van—
 - (i) drie rand vyf-en-tagtig sent (R3.85) per honderd pond ten opsigte van alle grade oondgedroogde tabak;
 - (ii) twee rand sestig sent (R2.60) per honderd pond ten opsigte van alle grade ligte luggedroogde en ligte Burley-tabak;
 - (iii) een rand vyf-en-tagtig sent (R1.85) per honderd pond ten opsigte van alle grade donker luggedroogde rol-, snuif- en donker vuurgedroogde snuif-tabak; en
 - (iv) een rand vyf-en-dertig sent (R1.35) per honderd pond ten opsigte van alle grade Turkse tabak, donker luggedroogde pyptabak, donker Burley-tabak, donker vuurgedroogde pyptabak, sigaartabak en Transkei-tabak.
