### DEPARTMENT OF AGRICULTURAL TECHNICAL SERVICES.

No. 759.] [19 May 1961.  
APPLICATIONS FOR THE ESTABLISHMENT OF SOIL CONSERVATION DISTRICTS.

Under section nine of the Soil Conservation Act, 1946 (Act No. 45 of 1946), as amended, I hereby give notice of the receipt of applications by the owners of farms situate in the magisterial districts and in the provinces as set out in the Annexure hereto, requesting the declaration of the areas defined in the Annexure hereto as soil conservation districts, for the following reasons:—

The farmers wish their respective areas to be declared soil conservation districts in order that provision may be made for the combating of soil erosion, the protection and development of the agricultural resources (the soil and the veld) and the effective utilisation of the rainfall and other water resources of the areas.

Any owner of land within the area concerned desiring to object to the declaration of his area as a soil conservation district, may, not later than 60 days as from the date of publication of this notice, lodge with the Minister of Agricultural Technical Services an objection, in writing, stating the reasons for such objection.
