#### PRICES OF CERTAIN DAIRY PRODUCTS— AMENDMENT.

In terms of sub-section (1) of section twenty-nine of the Marketing Act, 1937 (Act No. 26 of 1937), as amended, I, DIRK CORNELIS HERMANUS UYS, Minister of Agricultural Economics and Marketing, hereby make known that the Dairy Industry Control Board, referred to in section 3 of the Dairy Products Marketing Scheme, published by Proclamation No. 183 of 1954, has, in terms of section 19 of that Scheme, and with my approval, amended the prohibitions made known by Government Notice No. 342 of 1961, in the manner indicated in the Schedule hereto.

I do hereby further make known that the amendment relating to the prices payable with effect from 1st June, 1st July, 1st August and 1st October, 1961, shall come into operation on the first day of June, 1961, the first day of July, 1961, the first day of August, 1961, and the first day of October, 1961, respectively.

#### PRICES OF CERTAIN DAIRY PRODUCTS— AMENDMENT.

#### SCHEDULE.

#### LEVY ON FARM CHEESE.

In terms of sub-section (1) of section *twenty-nine* of the Marketing Act, 1937 (Act No. 26 of 1937), as amended, I, DIRK CORNELIS HERMANUS UYS, Minister of Agricultural Economics and Marketing, hereby made known that the Dairy Industry Control Board, referred to in section 3 of the Dairy Products Marketing Scheme, published by Proclamation No. 183 of 1954, as amended, has, in terms of section 23 of that Scheme and with my approval, imposed a levy on farm cheese at the rate of ·2c per lb. of such cheese, in substitution for the levy made known by Government Notice No. 735 of the 28th March, 1952.

I do hereby further make known that the said levy shall become operative on the first day of June, 1961.

#### SPECIAL LEVIES ON FACTORY CHEESE, CREAMERY BUTTER AND CONDENSING MILK.

In terms of sub-section (1) of section *twenty-nine* of the Marketing Act, 1937 (Act No. 26 of 1937), as amended, I, DIRK CORNELIS HERMANUS UYS, Minister of Agricultural Economics and Marketing, hereby make known that the Dairy Industry Control Board, referred to in section 3 of the Dairy Products Marketing Scheme, published by Proclamation No. 183 of 1954, as amended, has, in terms of section 24 of that Scheme and with my approval, imposed the special levies specified in the Schedule hereto, in substitution for the special levies made known by Government Notice No. 344 of the 24th February, 1961.

I do hereby further make known that the said special levies shall become operative on the first day of June, 1961.

(a) A special levy on factory cheese at the rate of—

- (i) 4·78c per pound of such cheese of the gouda type;
- (ii) 4·37c per pound of such cheese of the cheddar type;
- (iii) 2c per pound of such cheese other than of the cheddar or gouda type.

(b) A special levy on creamery butter at the rate of 2·04c per pound of such butter.

(c) A special levy on condensing milk at the rate of 18·5c per 100 lb. of such milk.
