BY HIS EXCELLENCY THE HONOURABLE LUCAS CORNELIUS STEYN, OFFICER ADMINISTERING THE GOVERNMENT OF THE UNION OF SOUTH AFRICA.

CANCELLATION OF DECLARATION AS A NATIONAL ROAD—PROVINCE OF THE CAPE OF GOOD HOPE: DECLARATION OF A NATIONAL ROAD—PROVINCE OF THE CAPE OF GOOD HOPE.

Whereas in terms of sub-section (1) of section four of the National Roads Act, 1935 (Act No. 42 of 1935), as amended, the National Transport Commission appointed under section three of the Transport (Co-ordination) Act, 1948 (Act No. 44 of 1948), as amended, has, after consultation with the Administrator of the Province of the Cape of Good Hope, recommended that Proclamation No. 67 of 1956 be cancelled in so far as the part of a road described in Part A of the Schedule annexed hereto is concerned and has, after consultation with the said Administrator, in terms of sub-section (1) of section four of the first-mentioned Act and sub-paragraph (a) of paragraph (i) of section nine of the last-mentioned Act, recommended that the part of a road described in Part B of the Schedule annexed hereto be declared to be a national road;

And whereas the construction or reconstruction or the proper maintenance of the part of a road described in Part B of the Schedule annexed hereto is, in my opinion, necessary in the national interest;

Now, therefore, under and by virtue of the power in me vested by paragraph (d) of sub-section (1) of section four of the first-mentioned Act, I hereby declare that Proclamation No. 67 of 1956 is cancelled in so far as this Proclamation concerns the part of a road described in Part A of the Schedule annexed hereto, with effect from the date of promulgation hereof, and under and by virtue of the power in me vested by paragraph (a) of sub-section (1) of section four of the first-mentioned Act, I hereby declare that the part of a road described in Part B of the Schedule annexed hereto, shall be a national road with effect from the date of promulgation hereof.

CANCELLATION OF DECLARATION AS A SPECIAL ROAD.—PROVINCE OF THE ORANGE FREE STATE: DECLARATION OF SPECIAL ROADS, PROVINCE OF THE ORANGE FREE STATE.

Whereas in terms of sub-section (1) of section four of the National Roads Act, 1935 (Act No. 42 of 1935), as amended, the National Transport Commission, appointed under section three of the Transport (Co-ordination) Act, 1948 (Act No. 44 of 1948), as amended, has, after consultation with the Administrator of the Province of the Orange Free State, recommended that Proclamation No. 45 of 1959 be cancelled in so far as the part of a road described in Part A of the Schedule annexed hereto is concerned and has, after consultation with the said Administrator, in terms of sub-section (1) of section four of the first-mentioned Act and sub-paragraph (a) of paragraph (i) of section nine of the last-mentioned Act, recommended that the parts of roads described in Part B of the Schedule annexed hereto be declared to be special roads;

And whereas the construction, reconstruction, repair or maintenance of the parts of roads described in Part B of the Schedule annexed hereto is, in my opinion, desirable in the public interest;
