#### GREETINGS.

WHEREAS I deem it expedient to appoint a Commission to investigate and report on the matters mentioned hereinafter;

NOW, THEREFORE, by reason of the great trust which I repose in your knowledge and ability I do by these presents authorize and appoint you to be Commissioners, and you Mr. Rocco Knobel to be Chairman, having regard to the importance of tourism to the country's economy as well as the contribution made by the hotel industry to the promotion of the tourist industry, to enquire into and report upon the following matters—

- (a) whether the hotel industry serves its purpose of, amongst others, providing in the needs of tourism and, if not, what are the shortcomings of the industry;
- (b) what are the factors impeding the healthy development of the industry; and
- (c) what measures are necessary and justified to enable the hotel industry to serve its purpose.
