SPECIAL LEVIES ON FACTORY CHEESE,
CREAMERY BUTTER AND CONDENSING MILK.

In terms of sub-section (1) of section twenty-nine of the marketing Act, 1937 (Act No. 26 of 1937), as amended, I, DIRK CORNELIS HERMANUS UYS, Minister of Agricultural Economics and Marketing, hereby make known that the Dairy Industry Control Board, referred to in section 3 of the Dairy Products Marketing Scheme, published by Proclamation No. 183 of 1954, as amended, has, in terms of section 24 of that scheme and with my approval, imposed the special levies specified in the Schedule hereto, in substitution for the special levies made known by Government Notice No. 814 of the 1st June, 1963.

I do hereby further make known that the said special levies shall become operative on the first day of November, 1963.

SCHEDULE.

- (a) A special levy on factory cheese at the rate of—
(i) 2·38c per pound of such cheese of the gouda type;
(ii) 2·46c per pound of such cheese of the cheddar type; and
(iii) 2c per pound of such cheese other than of the cheddar or gouda type.

(b) A special levy on creamery butter at the rate of 2·2c per pound of such butter.

- (c) A special levy on condensing milk at the rate of—
(i) 6c per 100 lb. of such milk purchased or otherwise acquired for the manufacture of skim-milk powder; and
(ii) 14c per 100 lb. of such milk purchased or otherwise acquired for the manufacture of a product other than skim-milk powder.

PRICES OF CERTAIN DAIRY PRODUCTS.—
AMENDMENT.

In terms of sub-section (1) of section *twenty-nine* of the Marketing Act, 1937 (Act No. 26 of 1937), as amended, I, DIRK CORNELIS HERMANUS UYS, Minister of Agricultural Economics and Marketing, hereby make known that the Dairy Industry Control Board, referred to in section 3 of the Dairy Products Marketing Scheme, published by Proclamation No. 183 of 1954, as amended, has, in terms of section 19 of that scheme, and with my approval, further amended the prohibitions made known by Government Notice No. 342 of 1961, in the manner indicated in the Schedule hereto.

I do hereby further make known that the amendment shall come into operation on the First day of November, 1963.

SCHEDULE.

The prohibitions imposed in connection with the sale of certain dairy products, made known in the Schedule to Government Notice No. 342 of the 24th February, 1961, as amended, are hereby further amended as follows:—

1. By the substitution for paragraphs (1), (2), (3) and (4) of clause 1 of the following paragraphs:—

“(1) factory cream of the grade indicated otherwise than on the basis of its butterfat content or at prices other than those specified below per lb. of butterfat contained therein:—

Grade.	Price. c
First.....	31½
Second.....	29½
Third.....	27½

- (2) cheesemilk at a price other than 150c per 100 lb. of such milk containing 3·5 per cent butterfat;
 (3) condensing milk for the manufacture of skim-milk powder at a price other than 150c per 100 lb. of such milk containing 3·5 per cent butterfat;
 (4) condensing milk for the manufacture of a product other than skim-milk powder at a price other than 160c per 100 lb. of such milk containing 3·5 per cent butterfat.”

2. By the substitution for clause 3 of the following clause:—

“Cheese Prices.”

3. No person shall sell factory cheese—

(1) of the cheddar type and the grade indicated at prices below the minimum or above the maximum prices specified hereunder:—

Grade.	Minimum Selling Price per lb.	Maximum Selling Price per lb.
First.....	26	30
Second.....	25	29
Third.....	23	27

Provided that—

- (a) in the case of a whole, uncut cheese weighing—
 (i) not more than 12 lb. but more than 5 lb., the minimum and maximum prices specified above shall be increased by 1c per lb; or
 (ii) not more than 5 lb., the minimum and maximum prices specified above shall be increased by 2c per lb; and

Die verbodsbeplings opgelê in verband met die verkoop van sekere suiwelprodukte en afgekondig in die Bylae van Goewermentskennisgewing No. 342 van 24 Februarie 1961, soos gewysig, word hierby verder soos volg gewysig:—

1. Deur paragrawe (1), (2), (3) en (4) van klousule 1 deur die onderstaande paragrawe te vervang:—

„(1) fabrieksroom van die graad aangedui, verkry, verkoop of van die hand sit nie, behalwe op die grondslag van die bottervetgehalte daarvan, en behalwe teen die prys hieronder vermeld per lb. bottervet wat dit bevat:—

Graad.	Prys. c
Eerste.....	31½
Tweede.....	29½
Derde.....	27½

(2) kaasmelk verkry, verkoop of van die hand sit nie teen 'n ander prys as 150c per 100 lb. van sodanige melk wat 3·5 persent bottervet bevat;

(3) kondenseermelk vir die vervaardiging van afgeroomde-melkpoeier verkry, verkoop of van die hand sit nie teen 'n ander prys as 150c per 100 lb. van sodanige melk wat 3·5 persent bottervet bevat;

(4) kondenseermelk vir die vervaardiging van 'n produk behalwe afgeroomde-melkpoeier verkry, verkoop of van die hand sit nie teen 'n ander prys as 160c per 100 lb. van sodanige melk wat 3·5 persent bottervet bevat.”

2. Deur klousule 3 deur die onderstaande klousule te vervang:—

„Kaasprysse.”

3. Niemand mag fabriekskaas—

(1) van die cheddar-type en die graad aangedui teen 'n laer prys as die minimum prys of 'n hoër prys as die maksimum prys hieronder vermeld, verkoop nie:—

Graad.	Minimum verkoopprys per lb.	Maksimum verkoopprys per lb.
Eerste.....	26	30
Tweede.....	25	29
Derde.....	23	27

Met dien verstande dat—

(a) in die geval van 'n hele, ongesnyde kaas wat—

- (i) nie meer as 12 lb. nie maar meer as 5 lb. weeg, die minimum en maksimum prys hierbo vermeld met 1c per lb. verhoog moet word; of
 (ii) nie meer as 5 lb. weeg nie, die minimum en maksimum prys hierbo vermeld met 2c per lb. verhoog moet word; en

- (b) in the case of specially matured cheese, graded as such and covered with a red wax—
- the minimum prices specified above shall be increased, and those increased in terms of proviso (a) to this sub-clause shall be further increased, by $3\frac{1}{2}$ c per lb; and
 - the maximum prices specified above shall not apply; and
- (2) of the gouda type and the grade indicated at prices below the minimum and above the maximum prices specified below:—

Grade.	Minimum Selling Price per lb.	Maximum Selling Price per lb.
First.....	26	30
Second.....	25	29

Provided that in the case of a whole, uncut cheese weighing—

- not more than 5 lb. but more than $1\frac{1}{2}$ lb., the minimum and maximum prices specified above shall be increased by 1c per lb; or
- not more than $1\frac{1}{2}$ lb., the minimum and maximum prices specified above shall be increased by $2\frac{1}{2}$ c per lb. and, if prepackaged by the manufacturer in cellophane or any other suitable synthetic film, by a further 1c per lb.”

- (b) in die geval van spesiaal beleë kaas, gegradeer as sodanig en bedek met 'n rooi waslaag—

- nie meer as 5 lb. nie maar meer as $1\frac{1}{2}$ lb. weeg, die minimum en maksimum pryse hierbo vermeld met 1c per lb. verhoog moet word; of
- nie meer as $1\frac{1}{2}$ lb. weeg nie, die minimum en maksimum pryse hierbo vermeld, verhoog moet word met $2\frac{1}{2}$ c per lb. en, indien deur die vervaardiger voorafverpak in cellophane of enige ander geskikte sintetiese omhulsel, met nog 1c per lb.”
