**HOUSE OF ASSEMBLY BY-ELECTION.—
ELECTORAL DIVISION OF MAYFAIR.**

Whereas it has been notified to me that a vacancy has occurred in the representation of the Electoral Division of Mayfair in the House of Assembly by reason of the resignation of Dr. Hendrik Gerhardus Luttig;

Now, therefore, under and by virtue of the powers and authority vested in me by sections *thirty-five* and *eighty-eight* of the Electoral Consolidation Act, 1946 (Act No. 46 of 1946), as amended, I do hereby declare—

- (1) that a vacancy exists in the representation of the Electoral Division of Mayfair in the House of Assembly;
- (2) that Wednesday, the twenty-four day of February, 1965, shall be the day on which a nomination court will sit to receive nominations of candidates for election as a member of the House of Assembly for the Electoral Division aforesaid;
- (3) that the place described in the second column of the Schedule hereto shall be the place at which the nomination court shall sit as aforesaid for such Electoral Division;
- (4) that the said nomination court shall sit at ten o'clock in the forenoon of the aforesaid day;
- (5) that, if a poll becomes necessary in the Electoral Division aforesaid for the reason that more than one person shall have been duly nominated at the close of the sitting of the said nomination court for such Electoral Division, the poll shall be taken
