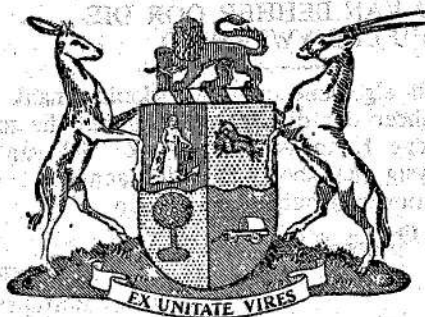

MEALIE AND KAFFIRCORN CONTROL SCHEME.
PRODUCERS' PRICE OF MEALIES.—AMENDMENT.

In terms of sub-section (1) of section *twenty-nine* of the Marketing Act, 1937 (Act No. 26 of 1937), as amended, I, DIRK CORNELIS HERMANUS UYS, Minister of Agricultural Economics and Marketing, hereby make known that the Mealie Industry Control Board, referred to in section 3 of the Mealie and Kaffircorn Control Scheme, published by Proclamation No. R. 113 of 1961, as amended, has, in terms of section 27 of that Scheme, with my approval and with effect from the date of publication hereof, amended the prohibitions made known by Government Notice No. R. 591 of 30th April, 1965, as set out in the Schedule hereto.

SCHEDULE.

Government Notice No. R. 591 of 30th April 1965, is hereby amended by:—

- the insertion of the symbol "WF3" after the symbol "WF2" in the column under the heading "Grade" in Table A contained in paragraph (a) of sub-clause (1) of clause 1 in Schedule A and the insertion opposite the said symbol "WF3" of the figures "290", "263" and "264.5" in column 1, column 2 and column 3, respectively;
- the insertion of the symbol "WF3" after the symbol "WF2" in sub-paragraph (ii) of paragraph (b) of sub-clause (1) of clause 1 in Schedule A;
- the insertion of the symbol "WF3" after the symbol "WF2" in the column under the heading "Grade" in Table B contained in paragraph (a) of sub-clause (1) of clause 1 in Schedule B and the insertion opposite the said symbol "WF3" of the figures "290", "263" and "264.5" in column 1, column 2 and column 3, respectively; and
- the insertion of the symbol "WF3" after the symbol "WF2" in sub-paragraph (ii) of paragraph (b) of sub-clause (1) of clause 1 in Schedule B.
