## GOVERNMENT NOTICE

### DEPARTMENT OF COMMUNITY DEVELOPMENT

**RESTRICTIONS ON THE ERECTION, ALTERATION OR USE OF BUILDINGS OR STRUCTURES IN FURTHERANCE OF SLUM CLEARANCE AND URBAN RENEWAL SCHEME IN CERTAIN DEFINED AREAS IN CAPE TOWN.**

It is hereby notified for general information that the Community Development Board established in terms of section two of the Community Development Act, 1955 (Act No. 69 of 1955), has, within the areas defined in schedules A and B hereof and with a view to the furtherance of slum clearance or an urban renewal scheme, in terms of the provisions of paragraph (e) of sub-section (2) of section twelve of the aforesaid Community Development Act, except with the written consent of the said Community Development Board prohibited for a period of ten years the erection or alteration of any building or structure or the use of any existing building or structure for a purpose other than the purpose for which such building or structure was being used on the date of publication of this notice.

Attention is also invited to the fact that any owner of immovable property in the areas referred to in the said schedules, who wishes to dispose of such property should as has been laid down in paragraph (a) of sub-section (5) of section twelve of the said Act, offer such property for sale to the said board when the further provisions of the said paragraph (a) are applicable to such transaction.

This notice substitutes Government Notice No. 809 which was published on the 4th June, 1965, in *Government Gazette Extraordinary* No. 1129 and the notices in *Die Burger* and *Cape Argus* of that date and which is hereby withdrawn.

### Schedule A.

From the crossing of Roeland and Canterbury Streets in a north-easterly direction along Canterbury Street up to Sir Lowry Road; thence eastwards along Sir Lowry Road up to Tennant Street; thence in a general south-easterly direction along Tennant and De Villiers Streets up to where De Villiers Street meets Roeland Street; thence north-westwards along Roeland Street to the first-mentioned point.

Hiermee word vir algemene inligting bekend gemaak dat die Gemeenskapsontwikkelingsraad ingestel kragtens artikel twee van die Wet op Gemeenskapsontwikkeling, 1955 (Wet No. 69 van 1955) met die oog op die bevoor-dering van slumopruiming of 'n stadshernuwingskema krag-tens die bepalings van paragraaf (e) van sub-artikel (2) van artikel twaalf van die gemelde Gemeenskapsontwikke-lingswet om die oprigting en verandering, behalwe met skriftelike goedkeuring van die gemelde Gemeenskaps-ontwikkelingsraad van enige gebou of struktuur binne die gebiede in bylaes A en B hiervan omskryf, of die gebruik, behalwe met sodanige goedkeuring, van 'n bestaande gebou of struktuur binne daardie gebiede vir 'n ander doel as die doel waarvoor die gebou of struktuur op die datum van publikasie van hierdie kennisgewing gebruik was, verbied vir 'n tydperk van 10 jaar.

Aandag word voorts daarop gevestig dat enige eienaar van onroerende eiendom in die gebiede in die bylaes gemeld, wat so 'n eiendom van die hand wil sit, dit soos in paragraaf (a) van sub-artikel (5) van artikel twaalf van die gemelde Wet uiteengesit, aan die Gemeenskaps-ontwikkelingsraad te koop moet aanbied, wanneer die verdere bepalings van die gemelde paragraaf (a) op soda-nige transaksie van toepassing sal wees.

Hierdie kennisgewing vervang Goewermentskennisge-wing No. 809 wat op 4 Junie 1965 in *Buitengewone Staatskoerant* No. 1129 gepubliseer is en die kennisge-wings wat in *Die Burger* en *Cape Argus* van daardie datum in dieselfde verband gepubliseer is en wat hiermee herroep word.

### Bylae A.

Van die kruising van Roeland- en Canterburystraat in 'n noord-oostelike rigting langs Canterburystraat tot by Sir Lowryweg; daarvandaan ooswaarts langs Sir Lowryweg tot by Tennantstraat; daarvandaan in 'n algemene suid-westelike rigting langs Tennant-en De Villiersstraat, tot waar De Villiersstraat en Roelandstraat ontmoet; daarvandaan noord-weswaarts langs Roelandstraat tot by eersgenoemde punt.

**Schedule B.**

From the crossing of Roeland and De Villiers Streets in a general north-easterly direction along De Villiers and Tennant Streets up to Chapel Street; thence eastwards along Chapel Street to where it crosses the future Boulevard East; thence south-eastwards along Boulevard East to where Searle Street crosses it; thence south-westwards along Searle Street up to Chester Road; thence in an easterly direction along Chester Road up to Perth Road; thence southwards along Perth Road up to the crossing with Worcester Street; thence eastwards along Worcester Street up to the point where it meets Marsden Road; thence southwards along Marsden Road up to the point where the prolongation thereof crosses De Waal Drive; thence generally north-westwards along De Waal Drive to the first-mentioned point.

**Bylae B.**

Van die kruising van Roeland- en De Villiersstraat in 'n algemene noord-oostelike rigting langs De Villiers- en Tennantstraat tot by Chapelstraat; daarvandaan ooswaarts langs Chapelstraat tot waar dit die toekomstige Boulevard-oos kruis; daarvandaan suid-ooswaarts langs Boulevard-oos tot waar Searlestraat dit kruis; daarvandaan suidwaarts langs Searlestraat tot by Chesterweg; daarvandaan in 'n oostelike rigting langs Chesterweg tot by Perthweg; daarvandaan suidwaarts langs Perthweg tot by die kruising met Worcesterstraat; daarvandaan ooswaarts langs Worcesterstraat tot die punt waar dit Marsdenweg ontmoet; daarvandaan suidwaarts langs Marsdenweg tot by die punt waar die verlenging daarvan De Waal-rylaan kruis; daarvandaan algemeen noord-weswaarts langs De Waal-rylaan tot by die eersgenoemde punt.
