MAKSIMUM PRYSE VAN DROËVRUGTE.— WYSIGING.

Ingevolge subartikel (1) van artikel *nege-en-twintig* van die Bemarkingswet, 1937 (Wet No. 26 van 1937), soos gewysig, maak ek, DIRK CORNELIS HERMANUS UYS, Minister van Landbou-ekonomie en -bemarking, hierby bekend dat die Droëvrugteraad genoem in artikel 3 van die Droëvrugteskema, afgekondig by Proklamasie No. R. 302 van 1962, kragtens artikel 20 van daardie skema en met my goedkeuring, die Bylae tot die Aanhangsel van Goewermentskennisgewing No. 456 van 2 April 1965 gewysig het soos in die Bylae hiervan uiteengesit.

En voorts maak ek hierby bekend dat genoemde wysiging op die datum van publikasie hiervan in werking tree.

BYLAE.

Die Bylae tot die Aanhangsel van Goewermentskennisgewing No. 456 van 2 April 1965 word hierby gewysig deur die volgende paragraaf aan die end daarvan by te voeg:—

“(d) Wanneer die vrugte in Transvaal by die perseel van die koper afgelewer word, kan 1½c per lb. by die prys soos hierbo bepaal, gevoeg word.”

DRIED FRUIT SCHEME.

MAXIMUM PRICES OF DRIED FRUIT.— AMENDMENT.

In terms of sub-section (1) of section *twenty-nine* of the Marketing Act, 1937 (Act No. 26 of 1937), as amended, I, DIRK CORNELIS HERMANUS UYS, Minister of Agricultural Economics and Marketing, hereby make known that the Dried Fruit Board, referred to in section 3 of the Dried Fruit Scheme, published under Proclamation No. R. 302 of 1962, has, in terms of section 20 of that scheme, and with my approval, amended the Schedule to the Annexure to Government Notice No. 456 of the 2nd April, 1965, as set out in the Schedule hereto.

And, I do hereby further make known that the said amendment shall come into operation on the date of publication hereof.

SCHEDULE.

The Schedule to the Annexure to Government Notice No. 456 of the 2nd April, 1965, is hereby amended by the addition of the following paragraph at the end thereof:—

“(d) Where these fruits are delivered at a buyer's premises in the Transvaal, 1½c per lb. may be added to the prices determined above.”
