REGULASIES MET BETREKKING TOT DIE GRADERING, VERPAKKING, MERK EN INSPEKSIE VAN ORNITHOGALUMBOLLE VIR UITVOER BEDOEL.—WYSIGING

Die Staatspresident het, kragtens die bevoegdheid hom verleen by artikel 7 van die Wet op Uitvoer van Landbou-produkte, 1959 (Wet 10 van 1959), die regulasies met betrekking tot die gradering, verpakking, merk en inspeksie van ornithogalumbolle vir uitvoer bedoel, afgekondig by Goewermentskennisgewing R. 1277 van 27 Augustus 1965, gewysig soos in die Bylae hiervan uiteengesit.

BYLAE

Die Bylae van Goewermentskennisgewing R. 1277 van 27 Augustus 1965, word hierby soos volg gewysig:—

1. Regulasie 3 word hierby gewysig deur paragraaf (a) te skrap.

2. Regulasie 4 word hierby gewysig deur in subregulasie (1) die woord "Koedoegebou" te skrap.

3. Regulasie 5 word hierby gewysig deur—

(a) subregulasie (2) deur die volgende subregulasie te vervang:—

"(2) Die spesifikasies vir Uitvoergraad is soos volg—

(a) Die ornithogalumbolle moet skoon, gesond en sonder vreemde stowwe wees en moet 'n omtrek van minstens drie sentimeters of 'n deursnee van minstens 'n $\frac{3}{8}$ duim hê.

(b) Die bolle moet goed ontwikkel wees, sonder misvorming, letsels, gebreke, insekte of insekbesmetting: Met dien verstande dat vergroening nie as 'n gebrek beskou moet word nie."

(b) na subparagraaf (v) van subregulasie (3) (a) die volgende subparagraaf by te voeg:—

"(vi) *Groottereeks D.*—Die bolle moet 'n minimum omtrek van drie sentimeters of 'n minimum deursnee van 'n $\frac{3}{8}$ duim, en 'n maksimum omtrek van $4\frac{1}{2}$ sentimeters of 'n maksimum deursnee van $\frac{9}{16}$ duim, hê."

(c) paragraaf (b) van subregulasie (3) deur die volgende paragraaf te vervang:—

"(b) In enige groottereeks in enige besondere houer kan—

(i) hoogstens 8 persent van die bolle, volgens getal, kleiner wees as die voorgeskrewe minimum grootte vir die betrokke groottereeks: Met dien verstande dat geen bol kleiner as drie sentimeters in omtrek of 'n $\frac{3}{8}$ duim in deursnee mag wees nie; en

(ii) hoogstens 8 persent van die bolle, volgens getal, groter wees as die voorgeskrewe maksimum grootte vir die betrokke groottereeks."

REGULATIONS RELATING TO THE GRADING, PACKING, MARKING AND INSPECTION OF ORNITHOGALUM BULBS INTENDED FOR EXPORT.—AMENDMENT

The State President has, under the powers vested in him by section 7 of the Agricultural Produce Export Act, 1959 (Act 10 of 1959), amended the regulations relating to the grading, packing, marking and inspection of ornithogalum bulbs intended for export, published under Government Notice R. 1277 of 27 August 1965, as set out in the Schedule hereto.

SCHEDULE

The Schedule to Government Notice R. 1277 of 27 August 1965, is hereby amended as follows:—

1. Regulation 3 is hereby amended by the deletion of paragraph (a).

2. Regulation 4 is hereby amended by the deletion in subregulation (1) of the words "Koedoe Building".

3. Regulation 5 is hereby amended by—

(a) the substitution for subregulation (2) of the following subregulation:—

"(2) The specification for Export Grade shall be as follows:—

(a) The ornithogalum bulbs shall be clean, sound and free from foreign matter, and shall be of a circumference of not less than three centimetres or a diameter of not less than $\frac{3}{8}$ inch.

(b) The bulbs shall be well developed, free from malformation, blemishes, defects, insects or insect infestation: Provided that greening shall not be regarded as a defect."

(b) the addition after subparagraph (v) of subregulation (3) (a) of the following subparagraph:—

"(vi) *Size Range D.*—The bulbs shall have a minimum circumference of three centimetres or a minimum diameter of $\frac{3}{8}$ inch, and a maximum circumference of $4\frac{1}{2}$ centimetres or a maximum diameter of $\frac{9}{16}$ inch."

(c) by the substitution for paragraph (b) of subregulation (3) of the following paragraph:—

"(b) In any size range in any one container—

(i) not more than 8 per cent of the bulbs, by number, may be smaller than the prescribed minimum size for the relevant size range: Provided that no bulb shall be smaller than three centimetres in circumference or $\frac{3}{8}$ inch in diameter; and

(ii) not more than 8 per cent of the bulbs, by number, may be larger than the prescribed maximum size for the relevant size range."
