Act No. 46, 1969

WOOL AMENDMENT ACT, 1969.

ACT

To amend the Wool Act, 1967, in relation to the representation on the South African Wool Board of persons dealing in the course of trade with wool products and of processors of wool.

(English text signed by the State President.)
(Assented to 2nd May, 1969.)

BE IT ENACTED by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:—

Amendment
of section 5
of Act 59
of 1967.

1. Section 5 of the Wool Act, 1967, is hereby amended by the substitution for subsection (1) of the following subsection:

“(1) The board shall consist of twelve members who shall be appointed by the State President and of whom—
(a) nine shall represent producers of wool and be nominated in the manner prescribed by section 6;
(b) one shall be an officer of the Department of Agricultural Economics and Marketing or the Department of Agricultural Technical Services and be nominated by the Minister;
(c) one shall represent persons dealing in the course of trade with wool products and be nominated by an organization or organizations recognized by the Minister as representative of such persons; and
(d) one shall represent processors of wool and be nominated by an organization or organizations recognized by the Minister as representative of wool processors.”.

Short title.

2. This Act shall be called the Wool Amendment Act, 1969.

WOLWYSIGINGSWET, 1969.

Tot wysiging van die Wolwet, 1967, met betrekking tot die verteenwoordiging in die Suid-Afrikaanse Wolraad van persone wat as 'n besigheid in wolprodukte handel en van verwerkers van wol.

DAAR WORD BEPAAL deur die Staatspresident, die Senaat en die Volksraad van die Republiek van Suid-Afrika, soos volg:—

1. Artikel 5 van die Wolwet, 1967, word hierby gewysig Wysiging van deur subartikel (1) deur die volgende subartikel te vervang:
„(1) Die raad bestaan uit twaalf lede wat deur die Staatspresident aangestel word en van wie—
(a) nege wolkwakers verteenwoordig en op die by artikel 6 voorgeskrewe wyse benoem word;
(b) een 'n beampie in die Departement van Landbou-ekonomiese en -bemarking of die Departement van Landbou-tegniese Dienste is en deur die Minister benoem word;
(c) een persone verteenwoordig wat as 'n besigheid in wolprodukte handel en benoem word deur 'n organisasie of organisasies wat deur die Minister as verteenwoordigend van sodanige persone erken word; en
(d) een verwerkers van wol verteenwoordig en benoem word deur 'n organisasie of organisasies wat deur die Minister as verteenwoordigend van verwerkers van wol erken word.”.
