RAND WATER BOARD STATUTES (PRIVATE) ACT
AMENDMENT ACT, 1969.

ACT

To amend the provisions of the Rand Water Board Statutes (Private) Act, 1950, in respect of the expression "Minister of Health".

(Afrikaans text signed by the State President.)
(Assented to 6th May, 1969.)

BE IT ENACTED by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:—

Substitution of the expression "Minister of Health" in Act 17 of 1950, as amended by Act 29 of 1964.

1. The Rand Water Board Statutes (Private) Act, 1950, is hereby amended by the substitution for the expression "Minister of Health", wherever it occurs in that Act, of the word "Minister".

Short title.

2. This Act shall be called the Rand Water Board Statutes (Private) Act Amendment Act, 1969.
