**PROCLAMATION**

*by the State President of the  
 Republic of South Africa*

No. 127, 1969

Whereas by section *eight* of the Coloured Persons Representative Council Act, 1964 (Act 49 of 1964) it is provided that a Commission shall be appointed to divide the provinces into electoral divisions for the election of members of the Coloured Persons Representative Council of South Africa;

And whereas such Commission was duly appointed and has, as provided by section *eight* of the Coloured Persons Representative Council Act, 1964, divided the provinces as aforementioned into electoral divisions, each returning one member, and the said Commission has, in pursuance of subsection (4) of section *eight* of the aforementioned Act submitted to the State President a list of electoral divisions with the names given to them and a description of the boundaries of every such division;

And whereas by subsection (6) of section *eight* of the Coloured Persons Representative Council Act, 1964, it is provided that the State President shall proclaim the names and boundaries of the electoral divisions as finally settled and certified by the Commission;

Now, therefore, under and by virtue of the powers and authority vested in me as aforesaid I do hereby declare that the names and boundaries of the several electoral divisions as finally settled and certified by the Commission shall be those described in the Appendices to the Report of the said Commission published in this *Government Gazette*.

**REPORT OF THE DELIMITATION COMMISSION APPOINTED UNDER SECTION 8 OF THE COLOURED PERSONS REPRESENTATIVE COUNCIL ACT, 1964 (No. 49 OF 1964)**

Mr State President:

The undersigned, appointed by you as a Commission for the division of the provinces of the Republic of South Africa into electoral divisions under the provisions of section 8 of the Coloured Persons Representative Council Act, 1964 (No. 49 of 1964), has the honour to submit herewith its report.

1. Under the provisions of subsection (3) of the said section 8, Mr V. J. Haupt was appointed secretary of the Commission, and I record my thanks for his valuable services.

2. In terms of subsection (1) of the said section 8, the number of electoral divisions in the four provinces has been determined as follows:—

- (a) Twenty-eight electoral divisions in the case of the province of the Cape of Good Hope;
- (b) six electoral divisions in the case of the province of the Transvaal;
- (c) three electoral divisions in the case of the province of the Orange Free State; and
- (d) three electoral divisions in the case of the province of Natal.

3. Under the provisions of subsection (2) (a) of the said section 8, the quota of a province has been obtained by dividing the total number of voters in that province, as ascertained from an examination of the current voters' lists, by the number of electoral divisions into which that province was to be divided.

4. The number of voters in the various provinces, according to the figures furnished by the Regional Representatives of the Department of the Interior, is as follows:—

- (a) Province of the Cape of Good Hope: 451,250.
- (b) Province of the Transvaal: 40,231.
- (c) Province of the Orange Free State: 7,846.
- (d) Province of Natal: 17,576.

The quota for each province is:—

- (i) Province of the Cape of Good Hope: 16,116.
- (ii) Province of the Transvaal: 6,705.
- (iii) Province of the Orange Free State: 2,615.
- (iv) Province of Natal: 5,858.

5. The Commission has divided each province into electoral divisions in such a manner that the number of persons registered on the Coloured Voters' lists residing in each electoral division, is as nearly as may be equal to the quota for the province, but in a number of cases it has departed from the quota where such departure was justified by community or diversity of interests, means of communication, physical features and existing or future sparsity or density of population, in respect of which information was available. In no case has the Commission departed from the quota to any greater extent than 11·1 per cent more or 8·1 per cent less than the quota.

6. The Commission first undertook a provisional delimitation of the four provinces. Thereupon information was furnished by means of notices in newspapers, concerning where the instruments in respect of such provisional delimitation would be open to inspection and where and when representations could be made to the Commission in connection therewith.

**VERSLAG VAN DIE AFBAKENINGSKOMMISSIE AANGESTEL KRAGTENS ARTIKEL 8 VAN DIE WET OP DIE VERTEENWOORDIGENDE KLEURLINGRAAD, 1964 (No. 49 VAN 1964)**

Meneer die Staatspresident:

Die ondergetekende, deur u benoem as 'n Kommissie vir die verdeling van die provinsies van die Republiek van Suid-Afrika in kiesafdelings kragtens die bepaling van artikel 8 van die Wet op die Verteenwoordigende Kleurlingraad, 1964 (No. 49 van 1964), het die eer om sy verslag hierby aan u voor te lê.

1. Ingevolge die bepaling van subartikel (3) van gemelde artikel 8 is mnr. V. J. Haupt aangewys as sekretaris van die Kommissie, en ek betuig hiermee my dank vir sy waardevolle dienste.

2. Die getal kiesafdelings in die vier provinsies is deur subartikel (1) van gemelde artikel 8 soos volg bepaal:—

- (a) In die geval van die provinsie die Kaap die Goeie Hoop, agt-en-twintig kiesafdelings;
- (b) in die geval van die provinsie Transvaal, ses kiesafdelings;
- (c) in die geval van die provinsie Oranje-Vrystaat, drie kiesafdelings; en
- (d) in die geval van die provinsie Natal, drie kiesafdelings.

3. Ingevolge die bepaling van subartikel (2) (a) van gemelde artikel 8 is die kwota van 'n provinsie verkry deur die totale getal kiesers in die provinsie, soos vasgestel uit 'n ondersoek van die geldende kieserslyste, te deel deur die getal kiesafdelings waarin daardie provinsie verdeel moes word.

4. Die getal kiesers in die verskillende provinsies soos deur die Streekverteenwoordigers van die Departement van Binnelandse Sake verstrekk, is soos volg:—

- (a) Provinsie die Kaap die Goeie Hoop: 451,250.
- (b) Provinsie Transvaal: 40,231.
- (c) Provinsie Oranje-Vrystaat: 7,846.
- (d) Provinsie Natal: 17,576.

Die kwota vir elke provinsie is:—

- (i) Provinsie die Kaap die Goeie Hoop: 16,116.
- (ii) Provinsie Transvaal: 6,705.
- (iii) Provinsie Oranje-Vrystaat: 2,615.
- (iv) Provinsie Natal: 5,858.

5. Die Kommissie het elke provinsie op so 'n wyse in kiesafdelings verdeel dat die getal op die Kleurlingkieserslyste geregistreerde persone wat in elke kiesafdeling woon so na as moontlik met die kwota vir die provinsie gelykstaan, maar in 'n aantal gevalle is van die kwota afgewyk waar sodanige afwyking geregverdig was deur gemeenskaplikheid of verskeidenheid van belange, verkeersmiddele, natuurlike kenmerke en huidige of toekomstige dunheid of digtheid van bevolking waaromtrent inligting beskikbaar was. In geen geval is meer as 11·1 persent bo of 8·1 persent benede die kwota afgewyk nie.

6. 'n Voorlopige afbakening van die vier provinsies is eers gedoen. Daarna is by wyse van kennisgewings in nuusblaaië inligting verstrekk in verband met waar die stukke ten opsigte van sodanige voorlopige afbakening ter insae sou lê en waar en wanneer vertoë tot die Kommissie gerig kon word in verband daarmee.

7. As announced in the said notices, the Commission conducted public sessions at the places and on the dates set out below:—

- (1) In Bloemfontein on 21 February 1969;
- (2) In Johannesburg on 10 March 1969;
- (3) In Durban on 12 March 1969;
- (4) In Cape Town on 26 March 1969.

8. The Commission attaches hereto:—

(1) As Appendix A, an alphabetical list of the various electoral divisions in the four provinces as delimited by the Commission, together with a description of the boundaries thereof furnished by the Surveyors-General concerned.

(2) As Appendix B, the following maps as marked by the Surveyor-General concerned for each province, in accordance with information furnished by your Commission and showing the exact delimitation of the various electoral divisions:—

#### Transvaal

- (1) The province of the Transvaal.
- (2) The City of Johannesburg and the Witwatersrand.
- (3) The Witwatersrand and environs.

#### Natal

- (1) The Province of Natal.
- (2) The City of Durban.
- (3) The City of Durban and environs.

#### Orange Free State

- (1) The Province of the Orange Free State.

#### Cape of Good Hope

- (1) The Province of the Cape of Good Hope.
- (2) The Cape Peninsula.
- (3) Cape Town and environs.
- (4) The City of Port Elizabeth.

9. The Commission wishes to thank the Regional Representatives and other officials of the Department of the Interior, as well as the Surveyors-General, for their valuable co-operation and assistance.
